11	authority granted or issued by the banking commissioner under:												
12	(A) Subtitle A, <u>F, or G,</u> Title 3, Finance Code[-												
13	or any successor-to that law]; [or]												
14	(B) Chapter <u>151</u> [ <del>152, 153,</del> ] or 154, Finance Code;												
15	or												
16	(C) Chapter 712, Health and Safety Code;												
17	(2) a principal of an applicant under Subdivision $(1)$ :												
18	(3) an employee of or applicant for employment or												
19	volunteer with the Texas Department of Banking; or												
20	(4) a contractor or subcontractor of the Texas												
21	Department of Banking.												
22	SECTION 2. This Act takes effect September 1, 2013.
