- $1\,$ be counted as if the student attended school for purposes of
- 2 calculating the average daily attendance of students in the school
- 3 district. A student whose absence is excused under Subsection (b),
- 4 (b-2), $(b-4)_{L}$ or (c) shall be allowed a reasonable time to make up
- 5 school work missed on those days. If the student satisfactorily
- 6 completes the school work, the day of absence shall be counted as a
- 7 day of compulsory attendance.
- 8 SECTION 2. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2013.
