6	SECTION 1. The heading to Section 724.017, Transportation
7	Code, is amended to read as follows:
8	Sec. 724.017. TAKING OF BLOOD SPECIMEN.
9	SECTION 2. Section 724.017, Transportation Code, is amended
10	by amending Subsections (a) and (c) and adding Subsections (a-1),
11	(c-1), and (c-2) to read as follows:
12	(a) Only the following [a physician, qualified technician,
13	chemist, registered professional nurse, or licensed vocational
14	nurse] may take a blood specimen at the request or order of a peace
15	officer under this chapter:
16	(1) a physician;
17	(2) a qualified technician;
18	(3) a registered professional nurse;
19	(4) a licensed vocational nurse; or
20	(5) a licensed or certified emergency medical
21	technician-intermediate or emergency medical technician-paramedic
22	authorized to take a blood specimen under Subsection (c).
23	(a-1) The blood specimen must be taken in a sanitary place.
24	(c) A licensed or certified emergency medical

- 1 technician-intermediate or emergency medical technician-paramedic
- 2 may take a blood specimen only if authorized by the medical director
- 3 for the entity that employs the technician-intermediate or
- 4 technician-paramedic. The specimen must be taken according to a
- 5 protocol developed by the medical director that provides direction
- 6 to the technician-intermediate or technician-paramedic for the
- 7 taking of a blood specimen at the request or order of a peace
- 8 officer. In this subsection, "medical director" means a licensed
- 9 physician who supervises the provision of emergency medical
- 10 services by a public or private entity that:
- 11 (1) provides those services; and
- 12 (2) employs one or more licensed or certified
- 13 emergency medical technician-intermediates or emergency medical
- 14 technician-paramedics [In this section, "qualified technician"
- 15 does not include emergency medical services personnel].
- 16 (c-1) A protocol developed under Subsection (c) may address
- 17 whether an emergency medical technician-intermediate or emergency
- 18 medical technician-paramedic engaged in the performance of
- 19 official duties is entitled to refuse to:
- 20 (1) go to the location of a person from whom a peace
- 21 officer requests or orders the taking of a blood specimen solely for
- 22 the purpose of taking that blood specimen;
- 23 (2) take a blood specimen if the
- 24 technician-intermediate or technician-paramedic reasonably
- 25 believes that complying with the peace officer's request or order
- 26 to take the specimen would impair or interfere with the provision of

1	(3) provide the equipment or supplies necessary to
2	take a blood specimen.
3	(c-2) If a licensed or certified emergency medical
4	technician-intermediate or emergency medical technician-paramedic
5	takes a blood specimen at the request or order of a peace officer, a
6	<pre>peace officer must:</pre>
7	(1) observe the taking of the specimen; and
8	(2) immediately take possession of the specimen for
9	purposes of establishing a chain of custody.
10	SECTION 3. This Act takes effect September 1, 2013.
