2 of U.S. Army Staff Sergeant Omar L. Aceves of El Paso, who died
3 while bravely serving his country on January 12, 2011, at the age of
4 30; and

5 WHEREAS, Assigned to the 7th Engineer Battalion, 10th
6 Sustainment Brigade, 10th Mountain Division, Fort Drum, New York,
7 Staff Sergeant Aceves lost his life in Ghazni Province,
8 Afghanistan; and

9 WHEREAS, Americans owe a profound debt of gratitude to this
10 nation's servicemen and servicewomen, who make immeasurable
11 sacrifices for their country and who risk their very lives in its
12 behalf; and

13 WHEREAS, Exemplifying the highest ideals of the U.S. armed
14 forces, Omar L. Aceves inspired others with his fortitude,
15 tenacity, and courage; although his death leaves a void in the lives
16 of his loved ones, they will forever carry memories of this heroic
17 Texan close in their hearts; now, therefore, be it

19 hereby pay tribute to the life of Staff Sergeant Omar L. Aceves and
20 extend sincere sympathy to all those who mourn his passing; and, be
