ourselves to owe and be indebted
to the State of Tennessee in the
Penal Sum of Ten Thousand
(\$10,000.00) Dollars in our hands
and seals this 22nd day of July 1890

The condition of the
above obligation is such that
whereas the above bounden W. B.
Jones has been duly elected
or appointed as public guardian
for Henry County Tennessee
for the term of four years
from Jan^{ry} 1st 1890 now if the
said W. B. Jones shall well
and faithfully perform all
the duties which now are or
may hereafter be required of
him by Law as such Public
Guardian by receiving and
improving all of the estate

of the minors which may be
 committed to his care and in
 all things comply with the
 requirements of the Law in
 regard thereto then the obligation
 to be paid atherwise to remain
 in full force and effect.

said minors require it It is ordered
by the Court that W. B. James the
Public Guardian be and he is
hereby appointed guardian for
said minors and that Letters of
guardianship issue to him.

State of Tennessee Henry County
To W. B. James a citizen of Henry
County Whereas it appearing to
the County Court of said County
that Atta. Mary S. Minnie A. and
Sammi Wilson are minors
and the Court being satisfied
as to your right to the guardianship
of said minors and you having
given bond and qualified accord-
ing to Law as Public Guardian
and the Court having ordered

that letters of guardianship be issued
to you

You are therefore authorized
to take into your possession for
the use and benefit of said wards
The profits of the Lands, tenements
and hereditaments belonging to
said minors and also the goods
chattel and other personal
estate of said wards, to bring
such suits or actions in relation
thereto as may be deemed necessary
to obtain to the next court after the
date hereof, a statement on oath
of all the estate which shall
have come into your hands
or possession to exhibit annually
an account of the profits and
disbursements thereof to obtain
a new list of the estate of said
wards two years from the date
hereof and to renew your bond
as such and to faithfully
perform all the duties required
of you by Law in relation to
said guardianship and

upon the arrival at full age or
earlier if required to make
final settlement thereof, to
deliver and pay to the person
lawfully authorized to receive
the same, the moneys of said
estate, including the profits
arising therefrom, being
fair and just.

and Sammie Wilcan children
of Alexander Wilcan and wife
Mary and grand children
and heirs at law of Robert D.
Caldwell deceased. Whereupon
It appearing to the satisfaction
of the Court that said
guardian will in the near
future receive of the estate
and property of his said
ward a large additional
sum of money arising
from sale for distribution
of the real estate of his
ancestor the said Robert
D. Caldwell, and if further
appearing that the bond
of the said W. B. James
the public guardian is
insufficient in amount
to secure these additional
sums of money. It is ordered
by the Court that the
said W. B. James guardian
of the said Minnie Etta
Mary, Minnie and Sammie Wilcan

enter into an additional bond
with good and sufficient
sureties in the sum of
\$6000.00 for the faithful per-
formance of his duties as
such guardian, whereupon
came into court the said
W. B. Jones and along with
him came N. Y. Cavitt
and R. P. Leale as his sureties
and executed the bond in
the sum of Sixteen Thousand
Dollars which was acknow-
ledged in open court by
the principal and sureties
and examined and approved
by the court and ordered
to be recorded.
