To the Hon. County Court of said County:

Your petitioner Jno. F. Elliot respectfully represents that he is a resident of the County of Dallas, and State of Texas:

That heretofore, to wit: on or about May 1st, 1890, A.H. Thomas departed this life intestate, in said County and State, leaving an estate of the probable value of Fifteen Hundred (\$1500.)
