### Go Online to Notify TCEQ of Recycling Activities

You can now go online to submit the form, *Municipal Solid Waste Notice* of Intent to Operate a Recycling Facility. Released on April 20, this form allows applicants to notify the TCEQ of their intent to operate a recycling facility and/or a composting or mulching operation.

#### **New TV Recycling Rules in Effect**



A new television recycling program went into effect in Texas on May 1, 2012. If your business sells, manufactures,

For and about small businesses and local governments affected by environmental regulations

or recycles televisions, you should be aware of specific requirements under the new law. As of July 1, 2012, TV retailers must provide consumers with information on recycling televisions, and meet other TV sales requirements.

TV manufacturers and recyclers must register and meet additional requirements by Jan. 31, 2013. For details on these requirements, please visit <www.TexasRecyclesTVs. org>. You can find the rules online, <www.sos.texas.gov>, at 30 Texas Administrative Code, Chapter 328, Subchapter J.

#### TCEQ Adopts Compliance History Rule Changes

On June 27, 2012, TCEQ commissioners adopted revisions to the Compliance History rule. This rule allows the TCEQ to rate owners and operators of facilities regulated by certain state environmental laws. The TCEQ considers these ratings when issuing or renewing permits, when calculating penalties, and when determining a facility's eligibility for innovative TCEQ programs.

The following is a brief summary of some of the changes:

- Notices of Violations used in the ratings calculation will be limited to those issued one year prior to the date of the ratings calculation.
- Only major violations of the same nature and associated with the same environmental media (air, water, or land) will be considered when designating a repeat violator.
- Facilities will now be classified as unsatisfactory performers (formerly

- called *poor performers*) for having a rating calculation of more than 55 points. Under the previous rule, a poor performer was a facility with more than 45 points.
- The compliance history calculation will include credit for compliance with the ordering provisions of agency-issued Agreed Orders. Fourteen industry groups based on the North American Industry Classifications System were added to effectively compare and account for differences among regulated entities.
- The new rules became effective Sept. 1, 2012. You can find the Compliance History rule at 30 TAC Chapter 60. #### 2013 Dates to Remember

The TCEQ requires a number of reports, plans, and fees at different times throughout the year. To give small businesses and local governments a handy guide, the following list gives due dates for common TCEQ reports and fees. Please remember that this list may not be all inclusive; also, these items will not be applicable to all entities.

- Waste Reduction Policy Act: Executive Summary of Five-Year Pollution Prevention Plan, every fifth year
- 10 Groundwater or purchased water systems: Disinfectant Level
   Quarterly Operating Report
   (DLQOR)
- 18 TERP usage reports for grant recipients
- Wastewater Discharge: Biomonitoring Discharge Monitoring Report (DMR)
- **22** Texas Emission Reduction Plan (TERP) usage reports from grant recipients
- 25 Industrial and hazardous waste: annual summary report (paper filers)
  - Used-oil collection center: report every year and renew registration in odd numbered years
  - Used-oil filter handlers: renew registration and report in evennumbered years
- Water and wastewater investorowned utilities, districts, water supply corporations, and affected counties: regulatory assessment fees
  - Dry cleaners: quarterly registration fee

  - Any system providing water to a community water system shall deliver the applicable Consumer Confidence Report (CCR) to receiving systems
- 10 Groundwater or purchased water systems: DLQOR
- 20 Wastewater Discharge: DMR
- **30** Dry cleaners: quarterly registration fee

- **15** Liquid waste transporter: annual summary
- 30 Categorical industrial users that discharge to a publicly owned treatment works without an approved pretreatment program: semiannual report

  - Sludge Transporter: renewal of registration, every two years; annual summary report

- Community water systems: CCR Certificate of Delivery to TCEQ

- 19 TERP usage reports for grant recipients

- **30** All public drinking-water systems: public health service fee
