Know all men by these presents that I
R. A. Reeves of said County of Dallas do make, declare
and publish the following as my last will and testam-
ent hereby revoking all wills and testaments by me
at any time heretofore made.

Item First. I direct that all my just debts
be paid. Item Second. I appoint, ^{and} Tom Otway
to be my executor of my will and direct that no
bond or security of any kind be required of him.

Item Third. I direct that no other action
shall be taken in the County Court or in any
other Court exercising probate jurisdiction in
relation to the settlement of my estate than the
probatyng and recording of my will and the return
of an inventory, appraisement and list of claims of
my estate.

Item Fourth. My executor is authorized to bring
and defend suit for the protection of my estate, to
collect, compromise and adjust all claims without
suit, to release claims and to do such other acts as
he may deem proper in the settlement of my estate.

Item Fifth. I give to each of my sons, Otway,
Charles and Reuben the sum of two thousand dollars
and I authorize my executor to sell enough of my real
estate to pay and satisfy said sums or one or more of
my sons may take his portion in real estate at cash
value without a sale instead of money.

The above provision in favor of my sons is intended to make their portions equal with the portions I have heretofore given to my daughter Mary Word and to my son Willie D. Reeves in his lifetime.

Item Sixth I give the balance of my estate to my daughter Mary Word and to my sons, Otway, Charles and Reuben in equal shares and to my two grand children, Mary and Mills Reeves, child son of my deceased son Willie D. Reeves, together one share and if either of my said grand children should die before marriage or before arriving at the age of twenty one years, I direct that her or his part shall go to the survivor.

My executor is authorized to make farther sale of my estate if he finds it necessary to make partition and to carry into effect the provisions of my Will. Given under my hand this 28 day of April 1904

Dear Sir:

The Historical Association is preparing a reference book on the history of Texas to be called the Handbook of Texas. I am writing some of the material to be included in the book and have a sketch to do on the life of Reuben A. Reeves. He was originally from Palestine lived in Jefferson for a while and in 1874 moved to Dallas from where he was appointed by Governor Coke as an Associate Supreme Court Justice. He held this position for two years--until the constitution of 1876. That is the latest information we have on this man and would appreciate if you would check your records for further information. Perhaps his death date is recorded on some property transaction or his will.

As he was a well-known attorney it seems odd that I cannot find more information on the man. If he continued to reside in Dallas after his term as Supreme court justice it would seem that he would be a member of the Dallas Bar Association. However, he is not included as a member in the earliest report of theirs that is available here at the University--that of 1861. Perhaps you could refer my request to the Bar Association president in Dallas, if you cannot find any information.

I certainly will appreciate any help you may be able to give me and hope that I will hear from you soon.
