the sum of \$12,000. (Twelve Thousand
Dollars) being \$2,000. (Two Thousand

Byrd E. White & Lula P. White.

The aforesaid sum of \$12,000. has
been disposed of by your reporter,
as follows, viz:

Feb 1 1883 loaned \$1,600.00
Sixteen Hundred Dollars to J. C. Culbertson
taking his personal promissory note for
same, due 12 mos after date, with 12%
interest from date. Said note is
secured by a deed of Trust to J. M. White
for Lou P. White, on certain valuable
tracts of land in Ellis Co Texas, which
is recorded in Book of Mortgages &c. of
said Ellis County - pages 2890, 91 & 92.

Feb 10 1883, your reported loaned
One Thousand Six Hundred Dollars (\$1,600)
to C. C. Gibbons & L. Gibbons taking
their note payable Two years after
date, with interest at 12% per annum.
Said note is secured by a Deed of
Trust from C. C. Gibbons to Lou P. White
on land situated in Ellis County Tex.
which is recorded in Mortgage Book &c.
for Ellis County - page 61 & c.

Feb 27 1883, loaned to R. L. Linneman
Six Thousand Dollars (\$6,000.00) taking
his note due five years after date,
with Jackson Linneman as surety.
Interest on said note at 10% per annum.

due annually. Said note is further secured by a Deed of Trust from R. A. Culison to Louie White on lands in Ellis Co. Texas, which is recorded in Book F of Mortgages for said County page 103 & c. March 3-1883. your reporter loaned Twenty nine Hundred Dollars (\$2900.00) to H. P. Batcher and J. M. Batcher, taking their note with John and John C. Batcher as personal sureties, due Oct 1. 1886 with 10% interest payable annually. Said note is further secured by a Deed of Trust from H. P. Batcher to Louie White, on lands in Ellis Co. Texas, which is recorded in Mortgage Book F. page 115-116-117-118. Further detail in regards to the above loans is deemed unnecessary, since each note is amply secured, not only in the personal responsibility of the signers, but in the value of the collaterals.

The above loans aggregate \$12,000, the entire amount rec'd by your reporter from A. M. & W. P. White Admins of W. L. White's Deed.

Your reporter would further state that the greater part of her wards' estate, has not yet been placed in her custody.

Their respective interests in the moiety of W. L. White & your reporter's community property, remains to be determined by commissioners.

Some of said property, viz: A. S. & Nancy Clark's note, is yet in litigation.

In the preceding clause, your reporter has consulted the equality of her wards, by assigning each one an equal share in every note, so that profits & losses shall be equal.

In addition your reporter would state that she has placed Addie H. White, Minnie E. White, W. L. White, Mattie C. White & Karl S. White at school during the time embraced by the following accounts.
