New Municipal Solid Waste Rules

New rules for all aspects of municipal solid waste (MSW) management in Texas became effective March 27, 2006. The commission has restructured these new rules to spell out clearly whether a facility needs a permit, registration, notification, or is eligible for an exemption.

The new rules continue to address all aspects of landfill and transfer-station design, permitting, processing, and operations. In addition, medical waste management, grease- and grittrap processing, special waste, and MSW air authorization rules also changed.

Dry Cleaners: Get Registered!

In March 2006, the TCEQ sent letters advising unregistered dry cleaners and dry cleaning drop stations to make compliance changes before they undergo inspection. This letter began a window of opportunity to become compliant before an investigator shows up.

Investigators began visiting unregistered dry cleaners and drop stations in May.

The investigations may result in fines of up to \$50 per day if the site has been unregistered. Take a minute to make certain that your registration is up to date.

Remember, you must complete a separate Dry Cleaning Facility
Registration Form (TCEQ20092) for each dry cleaner

you operate and a separate Dry Cleaning

Drop Station Regis-

tration Form (TCEQ-20207) for each drop station you operate.

Once your registration forms are processed and adequate payment has been received, you will receive your registration certificate.

New Waste Manifest in Effect Sept. 5

Beginning September 5, 2006, waste generators must use a new uniform hazardous waste manifest form to conform to federal rules. The new manifest will be used nationwide and will replace <u>all</u> state-specific hazardous waste manifests, including the Texas manifest. The Small Business and Local Government Assistance program is proud to announce the completion of Public Drinking Water: A Guide for Local Governments (RG-422-LGG-2). This publication was developed to assist local officials in interpreting the revised public drinking water rules, give an overview of the programs administered by the Public Drinking Water Program, and provide financial and technical resources for water systems.

The guide covers requirements for complying with the rules, reporting criteria, investigations, certificates of convenience and necessity, and rates. System (STEERS) to allow electronic submittal of discharge monitoring reports (DMRs). Facilities covered under various water quality permits complete these required reports.

Features of the new system include:

- Online submittal of DMRs through Web forms; users need only an Internet connection and a Web browser. Users also can choose to upload their DMR data using an electronic file format.
- Users can verify and validate their DMR data before they actually submit it, and find and correct mistakes prior to submitting the data.
- Users get a detailed "Copy of Record" once the submittals are accepted, which allows users to view their DMRs and print out copies for their records.
- Users can access a detailed help system and supporting documentation.

Users can submit data electronically through the electronic-DMR (e-DMR) system for the following Texas Pollutant Discharge Elimination System (TPDES) permits where the TCEQ has enforcement authority:

 Industrial and domestic wastewater discharge individual permits • General permits for discharges from concrete production facilities (TXG110000), petroleum fuel or petroleum substances (TXG830000), and wastewater and contact storm water from petroleum bulk stations and terminals (TXG340000).

By using this system, you can save yourself the cost and expense of paper DMR submittals. The system is free to use for all regulated entities, and signup is simple. Do you register with the TCEQ as a(n):

- Underground Storage Tank contractor?
- Wastewater Operations company?
- Water Operations company?

If your registration has not been expired for more than 30 days, you can now renew online at www.tceq.state.tx.us/compliance/online_renewals.html.

To renew online, you need your registration number and your registration expiration date. You must use capital letters when entering your registration number (for example, RCAS12345). ■

Phase I MS4s serve populations greater than 100,000 and should hold a Texas Pollutant Discharge Elimination System (TPDES) permit. Phase II MS4s serve populations less than 100,000. Phase II MS4s in urbanized areas (as defined by the U.S. Census Bureau) will need to apply for a general permit (TXR040000) or meet a waiver when the TCEQ authorizes
