Many small businesses and local governments are unaware of state and federal rules intended to minimize pollution. The Texas Commission on Environmental Quality (TCEQ) provides FREE site visits through a special program of its Small Business and Local Government Assistance (SBLGA) section. It's called the Compliance Commitment (C2) Program. Participating in the C2 Program could help you qualify for a one-year exemption from scheduled TCEQ inspections.

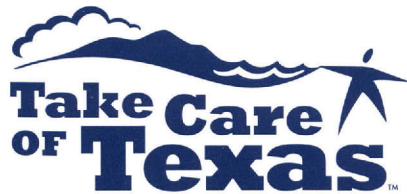

Small businesses and local governments all over Texas say the Compliance Commitment Program is a "huge help."

Are you eligible?

To be eligible to participate, a site or facility must be:

- An independently owned company that employs a companywide total of 100 or fewer employees; OR
- A county with a population of 100,000 or fewer; OR
- A city with a population of 50,000 or fewer; OR
- An independent school district (ISD) serving a student population of 100,000 or fewer students; AND
- Not owe any fees or penalties to the TCEQ; AND
- Not be involved in a current TCEQ enforcement action at the facility.

Just 3 Easy Steps

Step 1: Call SBLGA at 800-447-2827 to request a site visit. Our contracted consultant will call you back to schedule a site visit.

Step 2: During the site visit, the consultant uses a checklist to identify any compliance problems. After the visit, you will receive a report detailing recommended actions you can take to resolve

those problems. Many times, these options can save you money by improving the efficiency of your process and reducing the time you spend on paperwork.

Step 3: You'll have three to six months to correct deficiencies. You'll then be contacted to schedule a follow-up site visit. If you have made all necessary corrections, you will be eligible for SBLGA's Compliance Commitment (C2) Certificate.

The C2 Certificate will exempt your facility from TCEQ scheduled inspections for one full year.

Confidential and at No Risk*

- All information from the site visit is confidential: it is not provided to TCEQ enforcement staff.
- The site visit contractor is completely separate from state environmental field inspectors.
- Site visits will not lead to an inspection or citation.

The C2 Certificate Benefits

The C2 Certificate will EXEMPT your facility from TCEQ-scheduled inspections for one full year. The following programs also recognize the C2 Certificate:

- U.S. Environmental Protection Agency
- City of Corpus Christi, Storm Water Department
- City of Dallas, Air Pollution Control
- City of Dallas, Public Works and Transportation and Storm Water Management
- City of El Paso, Environmental Services—Air Quality Program
- City of Fort Worth, Department of Environmental Management
- City of Houston, Bureau of Air Quality Control
- City of Houston, Public Works and Engineering
- City of Pasadena, Public Works and Engineering
- City of Waco, Water Utility Services
- Brazoria County Environmental Health Department
- Fort Bend County Environmental Health Department
- Galveston County Health District
- Harris County Public Health and Environmental Services, Pollution Control Division
- Montgomery County Environmental Health Services

**However, if imminent threat to human health or the environment is discovered during the site visit, the contractor is required to report this information to the TCEQ.*
