You are hereby Commanded that
you summon David Bast a Minor
over the age of fourteen years, if to be
found in your County, to be and appear
before the County Court at the next
regular term thereof, to be held for Probate
and other like purposes, in and for said
County, at the Court-House thereof at
Dallas on the last Monday in December
instant (the same being the 30th day thereof)
then and there to choose a guardian for
his person and property; or a guardian
for the same, without good cause shown
will then and there be appointed by the
Court.

If you fail not but make due
return of this writ with your action
thereon as the law directs.
