Upon the application of David Galtie this day filed praying for the grant to him of temporary letters of administration upon the estate of Julius Gersul deceased, and it appearing to the court that said application is filed within three following the demise of said intestate and that the wife and widow of said intestate waives her right to be appointed administratrix of said estate, and it further appearing that the goods, wares and merchandise belonging to said estate are perishable and likely to waste, it is ordered and adjudged and decreed by the court that the said David Galtie be appointed temporary administrator of said estate upon his giving bond in the sum of \$1400. and that the goods wares and merchandise described in petitioner's application

be sold at private sale by said
Administrator forthwith and
that he make due notice
of said sale to our Honor-
able terms 1683 of the County
Court. It is further ordered
that A. Deyneboach, B. Brin-
wood, W. H. Hymen be ap-
pointed appraisers of said
estate.

Cornel D. Gaslinie tempo-
 rary administrator of said estate

after the payment of which claims
and expenses of administration
there remains in his hands the
sum of \$180. This administrator
represents that when the said Julius
Gersel died he left surviving
him Celia Gersel his wife and
widow. That she has no home-
stead, or other property or estate
and that under the law, as this
administrator is advised, she is
entitled to the remainder of said
fund in lieu of her homestead
and other exemptions, said sum
to be paid over to her in preference
to all other claims save those ex-
penses incurred in the adminis-
tration of this trust and the expen-
ses of said decedent's last sickness,
wherefore said administrator prays
for an order directing him
pay to said widow said fund
in his hands, and that he be discharged
from his said trust.
