In the name of God Amen!

I Miles Beeler of the County of Dallas & State of Texas, being sound in mind, but viewing the uncertainties of life and the certainty of death do make and ordain this my last will and testament. I will and bequeath to my two daughters Katy Alice Beeler and Nellie Ellen Beeler, jointly all my lands in Ellis county consisting of eleven hundred and eighty acres, and the undivided interest I have in my father's estate, also a lot of horses at this time running in Denton county, together with all other property both real and personal that I may die seized and possessed, with the exception of wheat lands, cattle and horses I have in the county of Jack & state of Texas, which property I will & bequeath to my wife Mary A. Beeler, for her support, and for the support of my said daughters, and for their (my said daughters education) the said land, cattle and horses is hereby willed to my wife absolutely. All the rest of my property is hereby willed to my daughters, to be given up to them at their marriage, or when they arrive at age. And if my said daughters should both die without issue born alive, the property hereby willed to them shall be divided between my relations by consanguinity according to the statute of descent & distribution of the State of Texas. I further will that the Probate Court shall take no further part or jurisdiction of my estate than to probate

my brother Geo. C. Beeler executor
of this my my last will

I do solemnly swear, that the writing which has
been offered for Probate, is the last Will of Miles
Beeler, late of Dallas County deceased, so far as I
know or believe and that I will well and truly
perform all the duties of Executor of the said Will.

County of Dallas, December Term 1866,
To the Honorable J. Ellis Coombes Chief Justice said County,
The Petition of Geo B Beeler respectfully shows, that on
the 5th day of December 1864 Miles Beeler, late a resident
citizen of said County, departed this life, and that, in
his lifetime, to wit, on the 22nd day of October 1864, the
said Miles Beeler, deceased, executed in writing, &
due form of law, his last Will and testament,
and thereby disposed of all his estate, both real
and personal, and therein named and appointed
your petitioner sole executor of said Will and
Testament, wherefor your petitioner comes and
files his application, as the law directs, and prays
that due notice thereof may be given, and that,
at the next regular Term of this Honorable Court,
to be held in and for said County, on the last
Monday in December instant, the said Will
may be admitted to probate, and letters testamentary
thereof granted to your petitioner, and your
petitioner will ever pray &c, Dec 6th 1866,
