Joseph Stewart, being
 sworn testifies as follows. I knew Samuel Steu
 at for 12 years. I know that he is hard to manage
 He acted like an insane man. He has
 been more or less insane for 20 years and
 is getting worse all the time He has had
 fits for 30 years he is not capable of managin
 g his business. I suppose this to have been
 caused by a lish on his head some 30 year
 ago. He does not recognize persons, not
 even his own children. He does not
 pretend to attend to his own business
 for has he for eight years. I do not
 regard him capable of attending to any
 business. He is boisterous & vicious in
 his conduct, frequently running off from
 home, and resists where an attempt to
 take him. Resisting any means of restraint
 or moral persuasion.

He cannot be safely kept in the county
 without confinement. He has three
 children in family. Two girls & one boy,
 one girl 19 and the other 17 years old & the
 Boy 14 years. They have no mother, and
 they have no way of maintaining themselves
 The value of his estate is 450 Acres of land
 worth \$420. Horses worth 1400 Cattle
 worth 1000 His age is 54 years.

Dr. C. C. Gillespie a practicing
Physician called and sworn states
that. I have know Mr Stewart between
3 & 4 years, and during that time he
was regarded as insane, and required
the attention of some able bodied person
to control him. he would frequently
get away from his keepers and lay out
in the woods. During the three years that
I knew him I practiced in his brother's
family where he stayed. and witness
his acts and conduct. I regard him in
a much worse condition now than
when I first knew him. I regard him
beyond all doubt. to be in a state of
insanity and wholly unsafe to be
kept anywhere unless confined.

Whereas Sam Stewart of Dallas County, an Insane person, has been admitted as a patient into the Texas State Locomatic Asylum.

Now therefore I the undersigned, in consideration thereof bind The County of Dallas to John F. Allen, Treasurer of the State of Texas and also of this Institution, to pay to him and his successors in office, the sum of two (2) dollars, specie, per week, for the care and board of said Insane person, so long as he shall continue in said Asylum, with such extra charges as may be occasioned, and also to provide him with suitable clothing, and pay for all such necessary articles of clothing as shall be furnished him by the State, and also to pay for all damage done to furniture and other property of said Asylum, and for all reasonable charges in case of elopement, and funeral charges in case of death; such payments for board and clothing to be made quarterly in advance, and also to remove or pay for his removal from the Asylum whenever the room occupied by him shall be required for a class of patient having preference by law, or when, for any other cause, it may be deemed expedient by the Superintendent or Board of Managers of said Asylum.
