

To all to Whom these Presents May Gome --- Greeting: KNOW YE, That John W Joter Principal, and Bit Bradford W. S. Sater Y Jill Channelten as sureties, are held and firmly bound unto the County Judge of the county of Dallas, in the sum of Cucht Heundred _____ Dollars, for the payment of which, well and truly to be made unto the said County Judge, we bind ourselves, our heirs, executors and administrators, jointly and severally, firmly by these presents. Signed with our hands, and scaled with our scals, the scals being scrolls, the 31^{20} day of Junney A. D. 1870. The Condition of the above obligation is such, That whereas the above John W Loter has been appointed Administrator of the Estate of Junes de Alford Now, if the said John Wy John sh deceased. shall well and truly perform all the duties required of him under said appointment, then this obligation shall be null and void, otherwise to remain in full force and effect.
