6th day of July, 1891, he received in money belonging to the es-
tates of said minors, the sum of \$405.00; and further represents
that on, to-wit, the 6th day of August, 1891, Norman B. Jones, mi-
nor, died intestate, aged six years, leaving surviving him his
sister, Edna C. Jones, age fourteen years; Cortez C. Jones, his

He further shows that he now has on hand belonging to




Now Comes W. A. Jones Guardian of the

Shows to the Court that on Sept. 4th 1894,
he made a report of his said Guardianship
in which report it was shown that as said
Guardian he received into his hands the
sum of Four Hundred and five Dollars
(\$405⁰⁰) belonging to said minors and
no more, also that prior to said
report Norman B. Jones, one of said
minors departed this life; that in the
discharge of his duties as such guardian
he had up to that time expended of
said funds so received the sum
of \$178.45, and had the remainder, that
is, the balance after deducting said
\$178.45 from \$405.00 in his hands - But
in said report stated that the balance
amounted to \$237.55 when it was in
fact only \$226.55 - Said report was
accompanied by Vouchers showing said
expenditures, and was by this Court
Approved May 29th 1897. Said report
also showed the payment of the then accrued
Costs, which amounted to the sum of \$9.95.

Jones would further show to the Court that since the making and approval of the above mentioned report he has as such guardian expended for said minors the total sum of Two Hundred and Twenty Seven & $\frac{98}{100}$ Dollars (\$227.95) which is shown by the vouchers hereto attached and marked Exhibit "A" and made a part hereof.

He would further show that the Costs remaining to be paid herein have been estimated by the Clerk of this Court, to amount to the sum of \$6.00, making a total amount of the sum of \$227.95 which makes \$1.40 more money than received by said W. A. Jones.




