 That I, Barbara Bopp wife
 of Jacob Bopp, of the County of Dallas
 and State of Texas, being in good health
 and of sound and disposing mind
 and memory, do make and publish
 this my last will and testament,
 hereby revoking all former wills by me
 at any time heretofore made -
 First. I direct all my just
 debts and funeral expenses to be fully
 paid and satisfied by my Executor,
 hereinafter named, as soon as con-
 veniently may be after my decease -
 Item - All the rest, residue and
 remainder of my Estate, Real and
Personal, whatsoever and wheresoever
 of which I may die seized and
 possessed or to which I may be en-
 titled at my decease I give and bequeath
 to my dear husband Jacob Bopp
 during his natural life, with full
 power to dispose and sell any or all
 of said property in fee simple as he
 may desire, and especially in regard
 to any Real Estate of which I
 may die seized and possessed,
 I design and hereby grant and give

to him full authority and power
to sell and execute conveyances in fee
simple of any part or all of said
Real Estate as he may desire
and appropriate the proceeds
thereof to his own use and benefit
as he may see proper.

Item - Now and after the death
of my said husband Jacob Popp,
I give and bequeath all the remain-
ing property or its proceeds, whether
Real or Personal of which I may
