Know all men by these presents that I Celestia H.
 Hickman of the County of Dallas, State of Texas,
 being of sound and disposing mind and
 memory do make and publish this my last
 will and testament, hereby revoking all wills
 by me at any time heretofore made,
 First; I give and bequeath to S. M. Poarch
 and Margaret E. Poarch my father and mother
 my Bank Stock, Notes, Cash and Life in-
 surance in the New York Life Insurance
 Company, of \$2000.00 also all that certain lot
 or tract of land situated in the Town of Middleton
 in Ellis County, Texas the same being 16 $\frac{3}{4}$ acres
 of land deeded to me by deed recorded in Vol.
 137, on Page 27 of the Deed Records of Ellis County,
 Texas. And I direct that my executor here-
 inafter named shall as soon as practicable
 after my decease, set said tract of land apart
 for a home for my said father and mother,
 and convert all the other property above men-
 tioned into money, and invest the same in
 land for the use and benefit of my said father
 and mother, And I expressly direct that said
 home and said lands purchased as aforesaid
 shall not be disposed of, for nor during the
 life time of either my said father or mother,
 but shall ^{be} held owned and enjoyed by them and

each of them so long as either shall live,
 to have and to hold the same to them the said
 S.M. Poarch and Margaret E. Poarch for and

Section Second: All the rest and residue of my

Section fifth: I direct that no other action shall be had in the county court in relation to the settlement of my estate than the proving and recording of this will, and the return of an inventory, appraisment and a list of claims of my estate.




