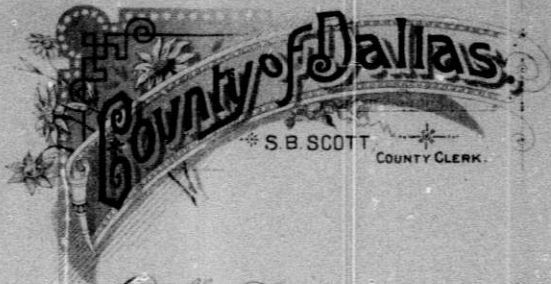

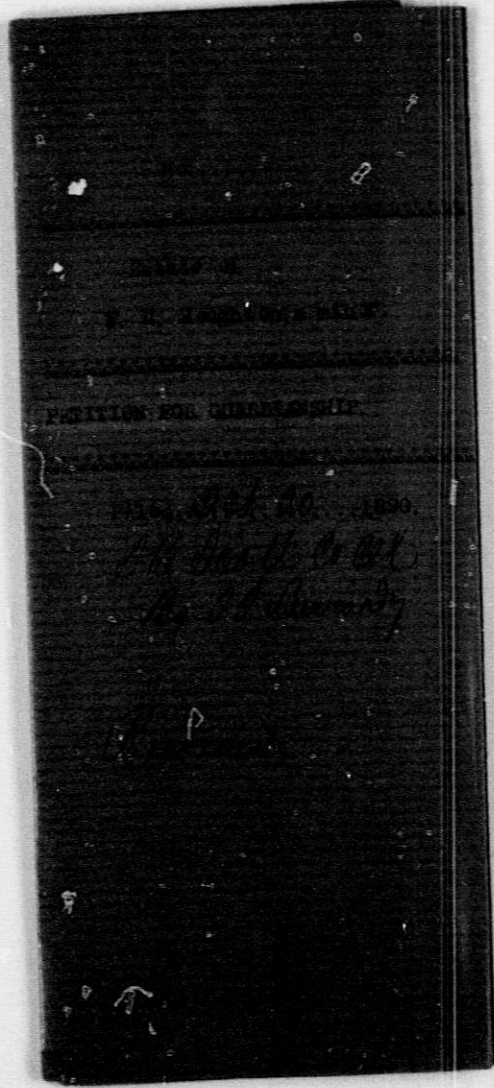
Wherefore petitioner prays that due notice hereof be given and an order appointing a guardian of said minor's estate; and for all necessary orders etc.
