William L. Abbott, who resides in Allegheny County, Pennsylvania, hereby makes application for the probate of the will of Elvira Wainwright and for letters testamentary thereunder, and shows to the court as follows the grounds of his application.

The said Elvira Wainwright was a widow, was aged more than twenty-one years, and at the time of making her last will and testament hereinafter mentioned she was of sound mind. She died March 26, 1904, at her home in Allegheny County, Pennsylvania, where she had resided for many years next preceding said date. At the time of her death she was the owner of a certain lot of ground in the City of Dallas, in Dallas County, Texas, situate on the North side of Main Street and extending from Pacific Avenue to Washington Avenue, the same being of the probable value of three thousand five hundred dollars. So far as this applicant is informed, said lot of ground is the only property of any kind owned by her in the State of Texas at the time of her death, or by her estate at this time. In the State of Pennsylvania she possessed a large estate.

On to-wit March 7, 1904, said Elvira Wainwright duly made and published her last will and testament, which on March 31, 1904, was duly admitted to probate in the county and state of her domicile, that is to say in Allegheny County, Pennsylvania. I, ELVIRA WAINWRIGHT, (widow of Zachariah Wainwright, deceased) of Pittsburgh, Allegheny County, Pennsylvania, do hereby make and publish this my last Will and Testament, written on four sheets of typewritten paper, each of which is identified by my initials, hereby revoking any and all former Wills by me at any time made.

FIRST: I desire that all my just debts and funeral expenses be paid by my executor hereinafter named as soon as convenient after my decease.

SECOND: I will and bequeath unto the Safe Deposit & Trust Company, of Pittsburgh, Pa., the sum of Twelve Thousand Dollars (\$12,000) in trust, to be by it invested and kept invested in such manner and in such securities as shall, in its judgment, be most advantageous to said trust. After payment of all expenses, including reasonable compensation, said trustee shall semi-annually pay the net income or profits therefrom unto my niece Mary Gallagher, daughter of my late sister Mary Gallagher, for and during the term of the natural life of my said niece. And these semi-annual payments to my said niece shall commence immediately after my decease. After the death of my said niece the said principal sum, together with such accumulations as may not have been paid to her, shall be divided into two equal parts, one of which shall be paid by said trustee unto my daughter Martha W. Floor, or, if she be then deceased, unto her next of kin; the other of which equal parts shall be paid by said trustee unto my daughter

living, share and share alike; but if he shall have left no issue living at the time of his death the said principal and accumulations shall be paid unto said Martha W.Bloor, or, if she be then deceased, unto her next of kin.
