Now comes Martha E. Beeman, and respectfully represents to the Court:-  
1st. That William H. Beeman, late of the County of Dallas, State of Texas, departed this life on the 14th. day of January, A.D. 1905; and, that he died in the County of Dallas, State of Texas.

2nd. That at the time of the death of the said William H. Beeman, and for many years prior thereto, he had been a bona-fide resident and Citizen of said County and State, and was living in Dallas County, Texas at the time of his death. That the said William H. Beeman died possessed of an Estate, situated for the most part in Dallas County, Texas, and that the County Court of Dallas County, Texas, has jurisdiction over said Estate.

3rd. That said Estate consists, for the greater part, of real and personal property and that same is of the probable value of \$ 12,000.00
