To the Hon County Court of said County -

Your petition Mrs. Elta M. Hardy, of the State and County aforesaid, shows and represents to you that she is the wife of J. C. Hardy deceased and the mother of Edgcor B. Hardy, a male 22 years old, George A. Hardy a boy 20 years old Feb. 1. 1893, Charles Hardy a boy 14 years Oct 28, 1893 and of Linwood Hardy a boy 12 years old March 4. 1893; all reside in said Dallas County, State of Texas and that no guardian of their persons or estate has been appointed; that said minors Chas. and Linwood Hardy are entitled to an Estate of the Estimated Value of two thousand dollars (\$2000) all of which is situated in Dallas County State of Texas; that ^{J. C. Hardy} the father of said minors, died the 20th day of November 1892 - and at the time of his death was a resident of Dallas County and that petitioner is not disqualified from receiving letters of guardianship.
