TO THE HONORABLE COUNTY COURT OF SAID COUNTY:

ARTHUR C. KEATING SHOWS: THAT EVA ELIZA KEATING IS A GIRL AND MINOR UNDER FOURTEEN YEARS OF AGE--TO WIT: NINE YEARS OF AGE; AND THAT ARTHUR GEORGE KEATING IS A BOY AND MINOR, UNDER FOURTEEN YEARS OF AGE--TO WIT: TWO AND -HALF YEARS OF AGE, RESIDING IN THE SAID COUNTY OF DALLAS, STATE OF TEXAS, THAT THEY ARE WITHOUT ANY LAWFUL GUARDIAN FOR THEIR PERSONS OR ESTATE, THAT SAID MINORS ARE ENTITLED TO AN ESTATE OF THE ESTIMATED VALUE OF EIGHT THOUSAND DOLLARS, CONSISTING OF PERSONAL PROPERTY, TO WIT:-- EIGHTY (80) SHARES OF STOCK IN THE KEATING IMPLEMENT & MACHINE COMPANY, SITUATED IN THE SAID COUNTY OF DALLAS, THAT YOUR PETITIONER IS THE FATHER OF SAID MINORS AND RESIDES IN THE COUNTY OF DALLAS, AND THAT HE IS NOT DISQUALIFIED FROM RECEIVING LETTERS OF GUARDIANSHIP UPON THE PERSONS AND ESTATES OF SAID MINORS;

WHEREFORE, HE PRAYS THAT NOTICE OF HIS APPLICATION BE GIVEN, AS REQUIRED BY LAW, AND THAT HE BE APPOINTED GUARDIAN OF THE ESTATES AND PERSONS OF SAID MINORS.
