To the Honorable Court Aforesaid:

Clara Emin, widow of J. Emin, deceased, hereinafter styled petitioner, would respectfully show to this Court that on the 9th day of January, A. D. 1904, the said petitioner and J. Emin were husband and wife, duly and lawfully married and residing in the City and County of Dallas and State of Texas, and were at said time possessed of a large estate, both real and personal, all of which was community; that on said day, to wit: the 9th day of January, 1904, the said J. Emin died intestate, leaving your petitioner his survivor and a son, Isaac Emin, who is now a resident of the City of Chicago, County of Cooke and State of Illinois, and is above the age of twenty-one years. That said Isaac Emin was the only child of your petitioner and the deceased, and neither your petitioner nor the deceased were ever married to any other person. That the said community estate consists of various pieces of realty situated in the City and County of Dallas and State of Texas, and of personalty such as household goods and stock and moneys in bank. That there are also outstanding against the estate various debts in, as your petitioner believes, the sum of about (\$1200.) Twelve Hundred Dollars. That there is also on hand a contract for the purchase of a piece of realty on Junias Street, being a half interest in a lot 260 x 104 feet, which was entered into by the deceased on or about the 5th day of January, A. D. 1904, and which it is the desire of your petitioner and her son aforesaid, Isaac Emin, to carry out. That both your petitioner and the only surviving child, the said Isaac Emin, are of the opinion that it is necessary for the best interests of the estate that your petitioner should qualify as community survivor, so as to have as wide a scope to her powers over the estate as it is possible for the law to grant.

Wherefore, your petitioner prays your Honor to appoint appraisers, as provided by law, to appraise said estate, and that upon the filing of the inventory, appraisement, list of claims and proper bond your petitioner be
