 now in feeble health, and knowing full well that death
 must soon overtake me, do hereby make, publish, and
 confirm this my last will and testament: hereby making
 any and all former wills by me made, and testaments
 to be my last will and testament.

And first of all I commit my body to the earth
 and my spirit to God who giveth it.

After my decease, it is my desire, and hereby will and
 bequeath, all of my real and personal estate of which
 I may die seized to my two beloved children, Fannie, now
 and Herrie, both of whom I do hereby give, devise, and
 bequeath to me and my two sisters by our father
 the Mother Wm. L. and Sarah W. W. W. W. deceased
 and known as the home stead of my said parents,
 do hereby intend being entitled of said tract of land:
 the said land being situated in Hunt County State of
 Texas. And my Community interest in and to the
 home stead owned by me and my said husband
 situated in Kaufman County State of Texas.

It is my desire that the said property be sold as soon
 after death, and the proceeds used for the education
 and support of my children aforesaid.

And should either of my said children die, then
 the whole of said estate shall vest in the surviving
 child. And should both of said children die before
 my said husband, then and in that event it is my will
 that the estate shall vest in my said husband.

For the carrying out the provisions of this my last will and testament I hereby nominate, constitute and appoint my husband W. W. Broughton, my executor of this my last will. I hereby authorizing him my executor to sell said estate had in will be private or public sale as he may deem best; and at such time as he may elect. In witness whereof my will, and I hereby direct that my said husband, and executor, take possession of and manage and dispose of said estate without being required to give bond and security; and that no security shall be required of my said executor. And I further direct that no proceedings be had in the Courts in regard to this my last will further than the proving and recording the same.
