## **THIRTY-FOURTH DAY**

(Wednesday, April 3, 2013)

SENATE BILL 614 ON SECOND READING**

**CSSB 614**, Relating to an electric utility surcharge to assist owners of certain historic structures with electric bill payments and to promote energy conservation and efficiency.

Amend **CSSB 614** (senate committee report) as follows:

(1) In SECTION 1 of the bill, in added Section 44.002, Utilities Code (page 1, line 37), strike "and".

(2) In SECTION 1 of the bill, in added Section 44.002, Utilities Code (page 1, line 39), between "adopted" and the period, insert the following:

; and

(5) has approved the application of this chapter to the county as provided by Section 44.004

(3) In SECTION 1 of the bill, in added Section 44.003(a), Utilities Code (page 1, lines 41-42), strike "in the general revenue fund".

(4) In SECTION 1 of the bill, in added Section 44.003(a), Utilities Code (page 1, line 42), strike "commission" and substitute "commissioners court of a county to which this chapter applies".

(5) In SECTION 1 of the bill, in added Section 44.003(b), Utilities Code (page 1, line 46), strike "commission" and substitute "commissioners court of a county to which this chapter applies by order".

(6) In SECTION 1 of the bill, in added Section 44.003(b), Utilities Code (page 1, line 48), between "cooperatives" and "to", insert "that provide service to a county that has approved the application of this chapter to the county as provided by Section 44.004".

(7) In SECTION 1 of the bill, in added Section 44.003(c), Utilities Code (page 1, line 53), strike "commission" and substitute "commissioners court of a county to which this chapter applies by order".

(8) In SECTION 1 of the bill, in added Section 44.003(d), Utilities Code (page 2, line 1), strike "commission by rule" and substitute "commissioners court of a county to which this chapter applies by order".

(9) In SECTION 1 of the bill, in added Section 44.003(e), Utilities Code (page 2, line 5), strike "commission" and substitute "commissioners court of a county to which this chapter applies".

(10) In SECTION 1 of the bill, in added Section 44.003(e), Utilities Code (page 2, line 6), strike "commission's".

(11) At the end of SECTION 1 of the bill, in added Chapter 44, Utilities Code (page 2, between lines 9 and 10), add the following:

(f) The commissioners court of a county to which this chapter applies may consult with the commission concerning the provision of energy assistance under this chapter.

Sec. 44.004. APPROVAL OF COMMISSIONERS COURT. (a) A commissioners court of a county by order may approve the application of this chapter to the county.

(b) A commissioners court of a county must hold a public hearing at which a member of the public may present testimony before the commissioners court approves the application of this chapter to the county.

SENATE BILL 352 ON SECOND READING**

**CSSB 352**, Relating to visitation for certain children in the temporary managing conservatorship of the Department of Family and Protective Services.

The bill was read second time.

Senator West offered the following amendment to the bill:

**Floor Amendment No. 1**

Amend **CSSB 352** (senate committee report) as follows:

(1) In SECTION 1 of the bill, in added Section 262.115(d), Family Code (page 1, lines 44-45), strike "that allows the most visits between the child and each parent of the child" and substitute "for the child's visits with each parent. The visitation schedule may conform to the department's minimum visitation policies".

(2) In SECTION 4 of the bill, in added Section 263.107(b), Family Code (page 2, lines 11-12), strike "that allows the most visits between the child and each parent of the child".

The amendment to **CSSB 352** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 1.

On motion of Senator West and by unanimous consent, the caption was amended to conform to the body of the bill as amended.

**CSSB 352** as amended was passed to engrossment by a viva voce vote.

All Members are deemed to have voted "Yea" on the passage to engrossment.

**SENATE BILL 352 ON THIRD READING**

Senator West moved that Senate Rule 7.18 and the Constitutional Rule requiring bills to be read on three several days be suspended and that **CSSB 352** be placed on its third reading and final passage.

**SENATE BILL 149 ON SECOND READING**

On motion of Senator Nelson and by unanimous consent, the regular order of business was suspended to take up for consideration **CSSB 149** at this time on its second reading:

**CSSB 149**, Relating to the Cancer Prevention and Research Institute of Texas.

The bill was read second time.

Senator Nelson offered the following amendment to the bill:

**Floor Amendment No. 1**

Amend **CSSB 149** (senate committee report) as follows:

(1) In SECTION 7 of the bill, in proposed Section 102.058(a), Health and Safety Code (page 3, lines 34-35), strike "receiving or applying to receive money from the institute" and substitute "described by this section".

(2) In SECTION 7 of the bill, strike added Section 102.058(c)(1), Health and Safety Code (page 3, lines 44-47), and renumber the subdivisions of Subsection (c) accordingly.

(3) In SECTION 7 of the bill, in added Section 102.058, Health and Safety Code, immediately following Subsection (c) of the section (between page 3, line 69, and page 4, line 1), insert the following:

(c-1) A person has a professional interest in an entity applying to receive money from the institute if the person is a member of the board of directors, the other governing board, or any committee of the entity, or of a foundation or similar organization affiliated with the entity, during the same grant cycle.

(4) In SECTION 7 of the bill, strike added Section 102.059(a)(7), Health and Safety Code (page 4, lines 38-39), and substitute the following:

(7) serve on the board of directors of:

(A) a nonprofit organization established with a grant from the institute;

or

(B) a grant recipient.

(5) In SECTION 7 of the bill, in added Section 102.059(d), Health and Safety Code (page 4, line 60), strike "commercialization" and substitute "development".

(6) In SECTION 7 of the bill, in added Section 102.063(a), Health and Safety Code (page 6, line 34), strike "commercialization" and substitute "development".

(7) In SECTION 7 of the bill, in added Section 102.063, Health and Safety Code, immediately following Subsection (g) of the section (page 6, between lines 65 and 66), insert the following:

(h) The compliance officer shall attend and observe the meetings of the program integration committee to ensure that the committee fulfills its duties under this chapter.

(8) In SECTION 8 of the bill, in amended Section 102.101(e), Health and Safety Code (page 7, line 11), strike ", at the time the person is appointed,".

(9) In SECTION 16 of the bill, in amended Section 102.251(a), Health and Safety Code (page 9, line 56), strike "commercialization" and substitute "development [commercialization]".

(10) In SECTION 16 of the bill, in added Section 102.251(d), Health and Safety Code (page 10, line 10), strike "The chief executive officer" and substitute "A member of the program integration committee".

(11) In SECTION 18 of the bill, in amended Section 102.255(b)(2), Health and Safety Code (page 10, line 47), strike ", as of a date specified in the contract," and substitute "[-, as of a date specified in the contract,]".

(12) In SECTION 21 of the bill, strike added Section 102.264(a), Health and Safety Code (page 12, lines 14-22), and substitute the following:

(a) The institute shall establish a program integration committee. The committee is composed of the following five members:

(1) the chief executive officer;

(2) the chief scientific officer;

(3) the development officer;

(4) the commissioner of state health services; and

(5) the chief prevention officer.

The amendment to **CSSB 149** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 1.



Senator Davis offered the following amendment to the bill:

**Floor Amendment No. 2**

Amend **CSSB 149** (Senate Committee Printing) in SECTION 20 of the bill, strike added Subsection (c) and add new Subsection (c) to read:

(c) The records of the institute and of a nonprofit organization established to provide support to the institute shall be made available to the public. A record that is available under this subsection is public information subject to Chapter 552, Government Code.

The amendment to **CSSB 149** was read.

Senator Davis withdrew Floor Amendment No. 2.

Senator Davis offered the following amendment to the bill:

**Floor Amendment No. 3**

Amend **CSSB 149** (senate committee printing) as follows:

(1) In the recital to SECTION 20 of the bill (page 11, line 24), strike "Subsection (c) and substitute "Subsections (c) and (d)".

(2) In SECTION 20 of the bill, in added Section 102.262, Health and Safety Code, immediately following Subsection (c) (page 11, between lines 32 and 33), insert the following:

(d) The institute shall post the records described by Subsection (c) on the institute's Internet website. The information posted on the website must include each donor's name and the amount and date of the donation.

The amendment to **CSSB 149** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 3.

Senator Davis offered the following amendment to the bill:

**Floor Amendment No. 4**

Amend **CSSB 149** (senate committee report) as follows:

(1) Immediately following SECTION 15 of the bill (page 8, between lines 68 and 69), insert the following:

SECTION 16. Section 102.203(e), Health and Safety Code, is amended to read as follows:

(e) Not less ~~[more]~~ than 10 percent of the money awarded under this subchapter each year must ~~[may]~~ be used for cancer prevention and control programs ~~[during any year]~~.

(2) Renumber subsequent SECTIONS of the bill accordingly.

The amendment to **CSSB 149** was read.

Amend **CSSB 672** (senate committee report) as follows:

(1) In SECTION 1 of the bill, in added Section 1202.107(a), Occupations Code (page 1, line 26), between "commission" and "or", insert ", executive director".

(2) In SECTION 1 of the bill, in added Section 1202.107(b), Occupations Code (page 1, line 33), strike "department" and substitute "executive director".

(3) In SECTION 1 of the bill, in added Section 1202.107(b), Occupations Code (page 1, line 33), between "penalty" and "in", insert "or sanction".

(4) In SECTION 1 of the bill, in added Section 1202.107(b), Occupations Code (page 1, line 35), between "commission" and "or", insert ", executive director".

The amendment to **CSSB 672** was read and was adopted by a viva voce vote.

All Members are deemed to have voted "Yea" on the adoption of Floor Amendment No. 1.
