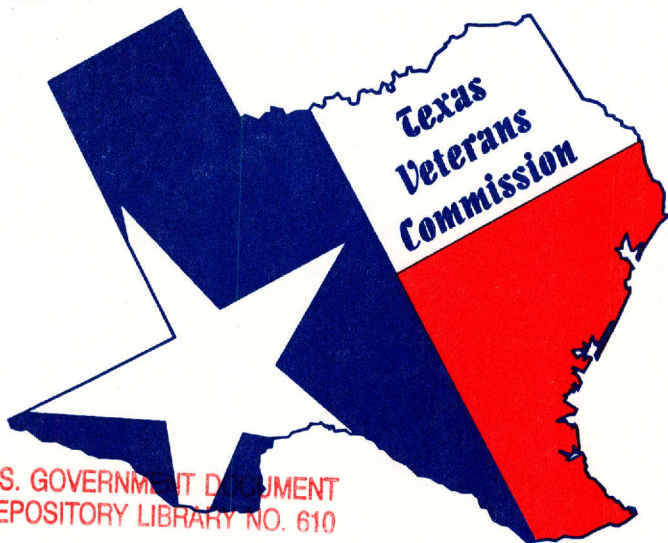

ARMED FORCES RESERVE

Two plates issued to passenger cars and light commercial vehicles owned by active or retired members of the U.S. Armed Forces Reserve. Application and the regular registration fee submitted to the Vehicle Titles and Registration Division*.

COAST GUARD AUXILIARY

Two plates issued to active or retired members of the Coast Guard Auxiliary. A annual special fee of \$10.00, used to administer the program, is charged in addition to the regular registration fee. Application and fee submitted to the Vehicle Titles and Registration Division. Additional sets may be purchased for \$15.00 each after the initial application.

DESERT STORM

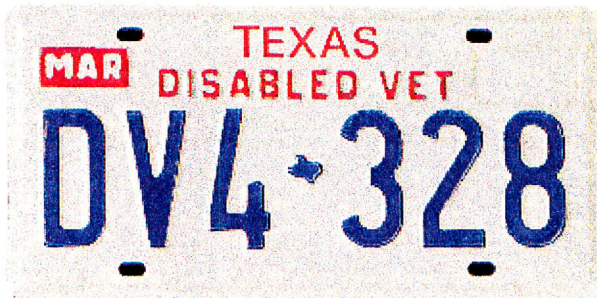
Two plates issued to members of the U.S. Armed Forces who took part in Operation Desert Shield/Storm. Application submitted to the Vehicle Titles and Registration Division. The regular registration fee submitted to the county tax assessor-collector's office when plates are approved. Qualified applicants may obtain additional sets of same type special license plates for the regular registration fees.

DISABLED VET

Two plates issued to Disabled Veterans that are certified by the U.S. Department of Veterans Affairs to have 60% service-related disability; or 40% due to amputation of lower extremity. Fee is \$3.00 annually. Application and fee submitted to Vehicle Titles and Registration. Surviving spouses of persons issued these plates are entitled to be issued plates for as long as they remain unmarried. Second set available at the applicable annual fee per plate.

FORMER POW

Two plates issued for persons who were captured and incarcerated by an enemy of the United States during a period of conflict with the United States. Plates have a "PW" prefix followed by three numbers and a one-letter suffix. A \$3.00 fee is collected to help administer this program. Applications must be filed with the Vehicle Titles and Registration Division. Only one set per applicant. Surviving spouses of persons issued these plates are entitled to be issued plates for as long as they remain unmarried.

GOLD STAR MOTHERS

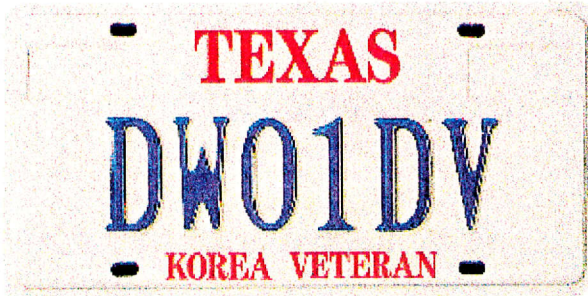
Two plates issued to passenger car or light truck. Fee is \$10.00 in addition to the regular registration fee. .50 goes toward the county in which the owner resides. \$9.50 will go to state highway fund. Application and special plate fee submitted to the Vehicle Titles and Registration Division. This plate is only available to a mother of a person who died while serving in the United States armed forces.

KOREA VETERAN

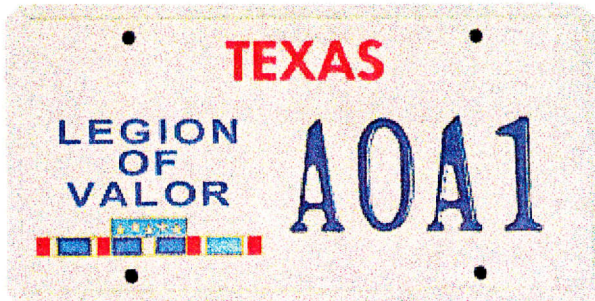
Two plates issued to members of the U.S. Armed Forces who were on active duty after June 26, 1950, and before February 1, 1955. Application submitted to the Vehicle Titles and Registration Division. The regular registration fee submitted to the county tax assessor-collector's office when plates are approved. Qualified applicants may obtain additional sets of same type special license plates for the regular registration fees.

LEGION OF VALOR

Two plates issued to recipients of the Air Force Cross, Distinguished Service Cross, Army Distinguished Service Cross, Navy Cross, and Medal of Honor. No annual vehicle registration fee is required, but a \$3.00 fee per year is collected to administer the program. Application and fee submitted to the Vehicle Titles and Registration Division.

MARINE CORPS LEAGUE

Two plates available to members of the Marine Corps League or its Auxiliary. A fee of \$10.00 is charged in addition to the regular registration fees prescribed by law. This fee administers the program. Application and special fee submitted to the Vehicle Titles and Registration Division.

PEARL HARBOR SURVIVOR

Two plates issued to passenger cars and light commercial vehicles owned by persons who were members of the U.S. Armed Forces, and were stationed in the Hawaiian Islands on December 7, 1941, or their unmarried surviving spouses. Survivors and unmarried surviving spouses pay \$3.00. Second set of plates are \$15.00. This fee is used to administer the program. Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of persons issued these plates are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration fees.

PURPLE HEART RECIPIENT

Two plates issued to passenger cars and light commercial vehicles owned by recipients of the Purple Heart medal, or their unmarried surviving spouse. A fee of \$3.00 is collected on the first vehicle and \$15.00, and regular registration, on any additional vehicles. Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of Purple Heart Recipients are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration fees.

TEXAS GUARD

Two plates issued to active or retired members of the Texas National Guard or Texas State Guard. Plate includes prefix of one number and letter "G" followed by four numbers. Issued to passenger cars and light trucks for one registration year. Application and regular registration fee must be filed with Vehicle Titles and Registration Division. Regular fee charged according to classification of vehicle.

U.S. AIR FORCE

Two plates issued to passenger cars and light commercial vehicles owned by active, retired, or honorably discharged members of the U.S. Air Force. A fee is of \$10.00 is charged in addition to the regular registration fee to administer this program. Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of persons killed in action are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration.

Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of persons killed in action are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration.

Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of persons killed in action are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration.

Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of persons killed in action are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration.

Application and fee submitted to the Vehicle Titles and Registration Division. Surviving spouses of persons killed in action are entitled to be issued plates for as long as they remain unmarried. Qualified applicants may obtain additional sets of same type special license plates for \$15.00 plus the regular registration.

The regular registration fee submitted to the county tax assessor-collector's office when plates are approved. Qualified applicants may obtain additional sets of same type special license plates for the regular registration fees.

WORLD WAR II VETERAN

Two plates issued to members of the U.S. Armed Forces who were on active duty after December 6, 1941, and before January 1, 1947. Application submitted to the Vehicle Titles and Registration Division. The regular registration fee submitted to the county tax assessor-collector's office when plates are approved. Qualified applicants may obtain additional sets of same type special license plates for the regular registration fees.
