

THE TEXAS MATCH THE PROMISE FOUNDATION

encourages families to save for college by offering matching scholarships and tuition grants to participants in the Texas Tuition Promise Fund* — the state's prepaid tuition plan.

Promise Fund tuition units represent a fixed amount of undergraduate tuition and required fees at Texas public colleges and universities. Match the Promise will award Promise Fund tuition units to approved scholarship recipients, supplementing participant contributions to the fund.

Matching Scholarship up to \$500

Up to \$500 of participant tuition unit purchases will be matched with the same number and type of tuition units for up to 150 top scoring applicants.

Promise Scholarship of \$2,000

A one-time grant of tuition units worth \$2,000 at today's prices will be awarded to the five applicants who score the highest.

The Match the Promise Foundation will accept applications postmarked **Sept. 1 through Dec. 31, 2012**. (Families can also enroll in the Promise Fund during this time if they haven't already done so.)

ELIGIBILITY CRITERIA

Applicants must meet the following criteria to apply for the Match the Promise program.

- Have a Texas Tuition Promise Fund account
- Be a Texas resident and a dependent for tax purposes of a Texas resident
- Be a student in grade six to nine
- Have a family income of \$75,000 or less

Students must write an essay about a career that interests them and submit the essay with this application. Applications will be scored by assigning points to career essays, grade averages, income levels and numbers of dependents.

TO SUBMIT AN APPLICATION

- 1. Provide the information requested on Pages 2-3 of this application.
- 2. Read and sign Page 4.
- 3. Include your child's career essay.
- 4. Include a copy of your child's school report card or transcript for the entire 2011-2012 school year.
- 5. Review the checklist on Page 5 to ensure the application is complete.
- Mail the completed application, including required documentation, to the address shown on the checklist.

- I have read, understand and agree to the terms and conditions of the Promise Fund Plan Description and Master
