During the last year the rules as cited on pages 4 through 10 of this Newsletter were developed and adopted by the SBDE. Thanks to all the Board members for their diligent efforts and hard work developing these rules and all other tasks assigned this past year.

As President of the SBDE, I appeared with SBDE staff before the Senate Finance Committee (January 7) and the House Appropriations Subcommittee on Regulatory Agencies (February 6) to support the agency's appropriations (i.e., budget)

request for the upcoming biennium (9-1-97 - 8-31-99). Dr. Miro Pavelka, Chair of the SBDE's Legislative Committee, appeared with SBDE staff before the House Appropriations Committee (February 27) in support of the SBDE's appropriations request.

There are a number of items in the SBDE's appropriations request that, if approved by the Legislature, would benefit the state's licensees. For example, we are hopeful the Legislature will appropriate monies to allow us to distribute this Newsletter at no charge to all of our licensees as a means of increasing our communications as we work toward better dentistry for all our citizens.

We sincerely appreciate the comments and support that many of you have given our Newsletter and hope that you will continue to let us know about your concerns and subjects of interest.

On March 13, Governor Bush reappointed Dr. James Kennedy, Dr. Cornelius Henry, Grant Lappin, Marcia Waugh, and Gail Wilks, RDH, to the Board for six-year terms, and appointed Dr. Michael Plunk to fill the vacancy left by Dr. James Bolton who had served 7 years, 2 as President. Dr. Plunk also will serve a six-year term. Congratulations to each of you and "Welcome Aboard" Dr. Plunk!

Congratulations are also in order for Dr. Kent Starr, the new Board President, and Dr. Ron Smith, the new Board Secretary. Good luck to each of you!

DENTAL HYGIENE ADVISORY COMMITTEE REPORT

The final adoption of rule 103.3, Licensure of Graduates of Foreign Dental Hygiene Schools or Programs occurred at the February 14 State Board of Dental Examiners (SBDE) meeting. The new rule establishes that graduates of foreign and non-accredited dental hygiene schools will be able to practice dental hygiene as mandated by the Texas Legislature through the Dental Practice Act. Article 4545a Section 2, a new provision in the Dental Practice Act, provides that the Board "....shall grant a license to a dentist or dental hygienist who has not graduated from a dental or dental hygiene school accredited the Commission on Dental Accreditation...." The statutory provision requires licensure if the applicant has practiced for five years, has not been disciplined, has passed all examinations required by the SBDE and the SBDE through a process set forth in rule has determined educational equivalency of the school that has graduated the applicant.

The full text of Rule 103.3 is cited on page 4 of this Newsletter.

The primary purpose of this rule is to spell out the procedure by which the SBDE will determine educational equivalency of an unaccredited school that graduates an applicant for licensure as a dental hygienist. In the summer of 1995, the SBDE asked the DHAC to determine whether the Texas dental hygiene schools could construct a qualifying clinical examination for dental hygienists similar to the process developed for dentists (i.e., a bench exam). The DHAC reported back to the SBDE that such an examination was not feasible for dental hygienists. The Board then appointed an ad hoc Joint Committee made up of the members of the DHAC and the members of SBDE's Credentials Committee and the Examination Committee. Subsequently, the joint committee was presented with a suggestion from the dental hygiene education community that educational equivalency could be determined by requiring graduation from a program of higher education of at least two academic years of full time study including specific course requirements.

The rule was proposed by the joint committee and the Board approved it for publication. In addition to describing a method determine educational to equivalency, the rule included the other statutory requirements for licensure of graduates of unaccredited dental hygiene schools. Oral comments were received at the SBDE's December 6, 1996 meeting, and written comments were filed. Public comments were made by and on behalf of the following organizations: Dental Hygiene Committee: Advisorv Texas Dental Hygienists' Association: Texas Dental Association: Dental Texas Hygiene Directors' Association; Texas Women's University; Tarrant County Jr. College; Lamar University: Wharton County Jr. College; Tyler Jr. College; Baylor College of Dentistry; University of Texas Medical Branch; Temple College. Four individuals made oral comments and 411 written comments were received concerning the rule. Written comments also were received from Lt. Governor Bullock, Representative Counts, Representative Delisi, and the Texas Dental Association.

The comments concerned many topics such as the following: substantive changes to the proposed rule, legislative intent of the Dental Practice Act, and procedures for rulemaking.

Given all of these comments, the SBDE accepted recommended changes from DHAC and added the terms "oral and written communications; immunology; preventative counseling and management with patients of special needs; and legal and ethical aspects of dental hygiene practice." DHAC proposed these additional course requirements so that of the Commission on Dental Accreditation (CODA) mandated curriculum requirements would included. be Furthermore, DHAC also recommended and the SBDE accepted language to provide that failing the clinical exam (required of all

applicants) three times will mean that an applicant must attend a CODA accredited school for two years. A similar provision is in the Dental Practice Act.

DHAC and the SBDE are following the course charted by the legislature by providing a rule to allow, under appropriate circumstances, graduates of foreign and unaccredited dental hygiene schools to become licensed.

The DHAC participated in amending Rule 117.1, Exemptions: the final adoption also occurred on February 14.

Final adoption of Rule 115.2, Permitted Duties, developed by DHAC and proposed to the SBDE concerns dental hygienists placing pit and fissure sealants. The SBDE now issues pit and fissure sealant certifications to all hygienists who have completed a course of instruction in a dental or dental hygiene school or college accredited by the Commission on Dental Accreditation of the American Dental Association.

For a dental hygienist to obtain certification to apply sealants in Texas, he/she must submit the following documents to the SBDE office:

- (1) a written request which includes the hygienist's name, mailing address, social security number, and Texas license number.
- (2) proof of course completion. This may be either (a) a course certificate, (b) a copy of the dental hygienist's transcript and a course description, or (c) a letter from the Dean or Program Director attesting to dental hygiene training and competency to apply sealants.

 NOTE: the letter must be written on school letterhead.

DENTAL LABORATORY CERTIFICATION COUNCIL REPORT

On behalf of the Dental Laboratory Certification Council I would like to extend special thanks to Dr. Miro Pavelka, Dr. Joe Zayas, and Ms. Pat Blackwell, for their diligence and assistance during the past year in developing and reviewing the new laboratory rules (Rule 116.2 - Rule 116.25) that are cited on pages 7, 8, and 9, of this Newsletter. The passage of these rules is a testament to this Board's dedication to the quality of care provided to dental patients of this state.

I would also like to take this opportunity to thank the Dental Laboratory Association of Texas, the Texas Dental Association, and the staff at the SBDE for their input addressing the concerns of all interested parties.

These new rules governing dental laboratories in this state were adopted by the SBDE at its February 14 meeting, and became effective March 18, 1997. The following are synopses of the new and amended rules:

Rule 116.2 broadens the definition of a dental technician.

Rule 116.3 clarifies that commercial and in-house laboratories using more than two technicians must be registered; requires labs to maintain prescriptions for two years; that a CDT may be designated as such for only one lab; outlines laboratory registration criteria; prevents owners from registering a new lab if any former lab registration has an outstanding balance of fees and penalties; requires that laboratory owners report personnel or location changes to the Board within 60 days, and requires that all laboratories are maintained in clean and sanitary condition.

<u>Rule 116.4</u> provides for assurance of continued competence of dental technicians.

<u>Rule 116.5</u> clarifies that a "grandfathered" laboratory registration cannot be renewed beyond the expiration of the registration.

<u>Rule_116.20</u> clarifies terminology used in dental laboratory rules.

Rule 116.22 requires an in house laboratory to be on premise of where the dentist owner is practicing and that the in house lab must register only when two or more technicians are employed.

Rule 116.24 provides that the Dental Laboratory Certification Council reviews all applications and recommended applications for registration to assure qualified dental laboratories are registered by the SBDE.

Rule 116.25 clarifies that the owner and manager of a laboratory are directly responsible for the registrations and operations of a laboratory and are subject to criminal penalties and loss of registration.

Finally, at the February 14 meeting, the SBDE reappointed Lester Eisenbeck, CDT, Milton Pokladnik, CDT, and me to continue serving on the Dental Laboratory Certification Council.

BOARD ADOPTS RULES

At the February 14, 1997, SBDE meeting, the Board adopted the following rules. These rules were duly published in the October 25, 1996, and December 24, 1996, issues of <u>Texas Register</u>. A public hearing was held on December 6, 1996, and written comments from the public were accepted on or before January 24, 1997. These rules became effective on March 18, 1997.

(new rule)

Rule 103.3 Licensing of Graduates of Foreign Dental Hygiene Schools or Programs

The State Board of Dental Examiners may grant a license to a graduate of a dental hygiene school or program not accredited by the Commission on Dental Accreditation of the American Dental Association upon payment of a fee, in the amount set by the Board, who meets all SBDE and State of Texas minimum applicant requirements, general licensure qualifications, and all of the following criteria:

- (1) Has submitted a completed application on a form provided by the SBDE;
- (2) Has presented a transcript in English from a dental or dental hygiene school which has a program equivalent to a Commission on Dental Accreditation of the American Dental Association dental or dental hygiene school or program.

- (A) If translation to English is necessary, all translations must be accomplished by a certified member of the American Translators and Interpreters Guild or the American Translators Association, provided the transcript is in a language for which certification is available.
- (B) If certification is not available, the translator must be a member of either organization listed above with at least three years experience interpreting the language in question.
- (C) Program equivalency is established by the following criteria:
- (i) the applicant must present proof in English that the program consists of a minimum of two academic years of full-time study, at the level of higher education or equivalent, involving at least 580 hours of clinical instruction, of which a maximum of 90 hours may be pre-clinical instruction;
- (ii) the program must consist of instruction in the following subjects: psychology; sociology; anatomy; physiology; biochemistry; general chemistry; microbiology; pathology; nutrition; pharmacology; pain control; tooth morphology; head, neck, and oral anatomy; oral embryology and histology; oral pathology; dental materials: periodontology; radiography; clinical hygiene (didactic and clinical instruction); oral health education; community dental health: patient management; medical and dental emergencies including basic life support; and infection and hazard control management; oral and written communications; immunology: preventative counseling and management with patients of special needs; and legal and ethical aspects of dental hygiene practice.
- (3) Has, after graduation as required, practiced dental or dental hygiene for five years immediately prior to applying;
- (4) Provides proof that no final or pending disciplinary action has been initiated in any jurisdiction in which he/she is or has been licensed:
- (5) Has passed a national written examination relating to dental hygiene as certified by the Joint Commission on National Dental Examinations;
- (6) Has successfully completed the appropriate clinical examination administered by the designated regional examining board;
- (7) Has successfully completed the SBDE's jurisprudence examination within six months prior to applying, and;
- (8) Provides proof of current certification in cardiopulmonary resuscitation given or approved by the American Heart Association or the American Red Cross.
- (9) An applicant for a license to practice dental hygiene applying under this rule 103.3 who fails

three times the qualifying clinical examination required by subsection (6) of this rule 103.3 shall be required to attend and successfully complete a two-year program at a dental hygiene school accredited by the Commission on Dental Accreditation of the American Dental Association.

(new rule)

Rule 107.300 Registration of Non-profit Corporations Authorized to Hire Dentists

The State Board of Dental Examiners will approve and certify any health organization to contract with or employ dentists upon submission of an application meeting the following requirements:

- (1) A written request to the Board by the organization's chief executive officer will suffice as the application;
- (2) The following documentation shall be submitted:
- (A) a copy of the certificate of incorporation under the Texas Non-Profit Corporation Act;
- (B) written proof of a determination by the Internal Revenue Service that the organization is tax exempt under the Internal Revenue Code pursuant to §501 (c)(3); and
- (C) written proof that the organization is organized and operated as a migrant, community or homeless health center under the authority of and in compliance with 42 United State Code §254 (b) or (c), or §2.56, or a federally qualified health center under 42 United States Code §1396d (1)(2)(B).
- (3) The Board may refuse to approve and certify or may revoke an approval or certification if in the Board's determination the non-profit corporation is established, organized, or operated in contravention of or with the intent to circumvent any of the provisions of the Dental Practice Act.

(amended rule) Rule 109.2 Content

- (a) A dentist legally engaged in the practice of dentistry may use signs which shall be on the premises and in the immediate area of the dental office to designate his professional office where he is actually engaged in the practice of his profession.
- (1) the sign shall contain the name of the practitioner licensed by the Texas State Board of Dental Examiners, or if a trade name is used, the names of the licensed dentist(s) practicing thereunder;

- (2) the sign shall contain the earned dental degree(s) or certificate(s) conferred on such practitioner, or the word or words "dentist," "dentistry," or "general dentistry;" however,
- (3) if he limits his practice, in accordance with Rule 109.107, of this title (relating to Specialty Advertising or Listings Limitation of Practice), he may add after the earned dental degree(s) or the word "dentist" or "dentistry" one of the following specialties:
- (A) Endodontics.
- (B) Oral Surgery or Oral and Maxillofacial Surgery.
- (C) Oral and Maxillofacial Pathology
- (D) Orthodontics and Dentofacial Orthopedics.
- (E) Pediatric Dentistry.
- (F) Periodontics.
- (G) Prosthodontics.
- (b) A dentist shall practice only under his own name or a trade name as set forth in the T.C.S., Article 4548(e) or as otherwise required by law. The names of all dentists practicing as associates, partners, or as employees in the same office shall be affixed to and on or immediately adjacent to the entrance door to such dental office. (See Chapter III of this title (relating to Professional Corporations).) The terms "earned dental degree(s) or certificate(s)" as used herein and in these sections means that such was earned by the licensee and was conferred on him by an accredited teaching institution recognized and approved by the accrediting authority of the American Dental Association and by the Texas State Board of Dental Examiners. Provided, however, a Texas dental licensee who has two or more earned dental degrees or certificates in different specialties may apply to the Board and be granted permission to announce and practice in such specialties upon satisfactory proof thereof being furnished to the Board.

(amended rule) Rule 109,91 Requirements

No dental licensee or dental hygiene certificate holder in this state shall offer, give, dispense, distribute, or make available to any person, or aid or abet another so to do, any gift, premium, chance, reward, ticket, item, or thing of value as a reward or inducement for obtaining a dental patient for any dental licensee or dental hygiene certificate holder.

(amended rule)

Rule 109.107 Specialty Advertising or Listings—Limitation of Practice.

- (a) Dentists may advertise as being a specialist in or practice limited to a particular field of dentistry; i.e. orthodontics and dentofacial orthopedics, pediatric dentistry, periodontics, prosthodontics, endodontics, oral and maxillofacial surgery oral and maxillofacial pathology, or dental public health, provided he or she is a specialist as defined by the American Dental Association.
- (b) The definition of a specialist as specified by this rule pertains to this and only this rule for the purpose of defining advertising and must not be randomly applied to any other law or rule of the Texas Dental Practice Act.
- (c) This rule does not preclude or limit any dentist from offering and performing any treatment to any patient as prescribed by the Texas Dental Practice Act. This rule does not preclude any dentist from advertising to the public the availability of any dental service to the public that a dentist may offer and perform as prescribed by the Dental Practice Act.
- (d) All dentists who have claimed to be dental specialists, or hold themselves to be engaged in a dental practice limited to, without regard to the American Dental Association criteria of specialization and can document such claim to have acted as such prior to January 1, 1965, may continue to act as such under the protection of this rule.
- (e) General dentists who wish to announce the services available in their practices are permitted to announce the availability of those services so long as they avoid any communications that express or imply specialization. General dentists shall also state that the services are being provided by general dentists. No dentist shall announce available services in any way that would be false or misleading in any material respect.

(amended rule)

Rule 109.141 Disclosure

- (a) A licensed dentist shall conduct his practice on the highest plane of honesty, integrity, and fair dealing. Neither the dentist nor his employee(s) shall mislead dental patients as to the gravity or lack thereof of such patient's dental needs.
- (b) On the written request of a patient, the licensed dentist shall provide, in plain language, a written explanation of the charges for professional services previously made on a bill or

statement for the patient. For this rule, the term "plain language" means language that avoids terms of art or usage of words having specialized meaning in a context typically understood only by health care professionals.

(amended rule)

Rule 109.211 Unprofessional, Dishonorable, and Immoral Conduct,

Unprofessional conduct, dishonorable conduct, and immoral conduct are synonymous terms when applied to the conduct of a dental licensee and include the following:

- (1) Conduct which violates standards of professional behavior which, through professional experience, has become established by consensus of professional opinion as being inimical to the protection of the public health, welfare, or interest.
- (2) Aiding, procuring, or abetting in violation of a criminal statute.
- (3) Participation in a conspiracy to procure (by corruption, fraud, misrepresentation, or bribery, or both) a dental license for an unqualified person.
- (4) Habitual use of drugs, narcotics, or alcohol which impairs a licensee's ability.
- (5) Practicing or attempting to practice dental fraud.
- (6) Instigating illegal examination or treatment of a dental patient by one not legally qualified so to do.
- (7) Using persons (others) to personally solicit dental patients whether for fee or free.
- (8) Grossly over prescribing or dispensing narcotic drugs, dangerous drugs, or controlled substances.
- (9) Prescribing or dispensing narcotic drugs, dangerous drugs, or controlled substances to or for a person who is not his dental patient, or not for a dental or maxillofacial surgery problem.
- (10) Indicating a fee for dental services on an insurance or other third party reimbursement claim form which is other than the fee which the dentist expects to collect for services rendered.
- (11) Violation of the terms of a Board order:
- (12) Committing any violation during a period of probation;
- (13) Failing to submit a report to the Board required by statute, rule, or Board order.
- (14) Conviction of any felony or misdemeanor involving fraud under the laws of this State or any other State or of the United States.
- (15) Providing dental services to any patient while employed by, or under any kind of contract whatsoever, with any person not licensed to practice dentistry or while such person's dental

license is currently expired, surrendered, suspended, or revoked, or providing dental services to any patient while employed, by or under any kind of contract whatsoever with, any organization not authorized by law to provide dental services.

- (16) Persistently or flagrantly overtreating a dental patient.
- (17) Overcharging a dental patient. For this rule the meaning of the term "overcharging" includes, but is not limited to, collecting or attempting to collect a fee without reasonable justification for any element of dental services provided to a patient that is in excess of the fee the dentist ordinarily charges to others for the same service.

(amended rule) Rule 115.2 Permitted Duties

In addition to those duties identified in Article 4551e-1(b)(2), a dental hygienist may perform the following services and procedures in the dental office of his/her dentist-employer under his/her general supervision, direction and responsibility, to wit:

- (1) apply pit and fissure sealants only after successful completion of a course of instruction in a dental or dental hygiene school or college accredited by the Commission on Dental Accreditation of the American Dental Association and approved by the State Board of Dental Examiners and after receipt of certification by the State Board of Dental Examiners. Certification to apply pit and fissure sealants in Texas may be obtained by submitting a written request accompanied by required proof of course completion.
- (2) monitor patients receiving nitrous oxide/oxygen inhalation conscious sedation only after obtaining certification issued by the State Board of Dental Examiners and only under the direct supervision of a Texas licensed dentist. Certification may be obtained by successful completion of the certification examination offered by the State Board of Dental Examiners.

(amended rule) Rule 116.2 Dental Technician

A "Dental Technician" is a person who performs the services as set out in Article 4551f (1) and includes, but is not limited to, all certified dental technicians who have a current certificate issued by the National Board For Certification For Dental Laboratory Technology, or its successor.

(amended rule) Rule 116.3 Requirements

- (a) A commercial dental laboratory and an inhouse dental laboratory with more than two dental technicians shall be registered according to the provisions of Texas Civil Statutes, Article 4551f (6) (a)-(c), if it is a place where a person undertakes to perform or accomplish any act or service listed in Texas Civil Statutes, Article 4551f (1). Permitted services to be performed under a written prescription from a licensed dentist in addition to those described in Article 4551f(1), include:
- (1) Shade taking. Dental laboratories providing this service shall institute and maintain infection control procedures for in-laboratory shade verification to protect the patient and laboratory staff from infectious contamination. Each laboratory shall:
- (A) Dedicate a specific area of the laboratory for performance of shade verification procedures.
- (B) Maintain the area used for shade verification in a neat, clean, and clutter free state at all times
- (C) Disinfect areas of patient contact both before and after each patient.
- (D) Provide a dedicated set of shade guides to be used only for patient shade verification. Disinfect shade guides before and after each use.
- (E) Provide a patient hand mirror for extraoral use. Disinfect mirror before and after each patient use.
- (F) Use a disinfecting agent for cleaning shade guides that are accidentally dropped.
- (G) Require that the technicians taking the shade wear protective clothing, including gloves.
- (2) Computer imaging as pertaining to the oral cavity by a registered laboratory. Computer imaging may be accomplished only when authorized by a written prescription from a licensed dentist. The result should be furnished to that dentist accompanied by a disclaimer to the patient that computer imaging is an artistic interpretation and does not guarantee exact results.
- (b) A dental laboratory shall furnish each licensed dentist from whom prescriptions are accepted with its permanent registration number and expiration date of such registration, and shall maintain for a period of two years any work orders of any laboratory with which it contracts services. The work order shall reflect the Texas registration number and registration expiration date of the contracted laboratory. No work may

be farmed out except to a Texas registered dental laboratory.

- (c) All dental laboratories first registered after September 1, 1987 must have a certified dental technician on premises a minimum of 30 hours per week. The certified dental technician may be the designated CDT of record for only one laboratory per registration period.
- (d) The Dental Laboratory Certification Council shall ensure that the following criteria are met for each new laboratory registration application and each renewal of any registration:
- (1) application/renewal is complete and all required information is provided.
- (2) current and active CDT certification for designated CDT, or, for grandfathered laboratories, proof of continuing education hours as outlined in Rule 116.4 of this title (relating to Continuing Education) is attached and current,
- (3) appropriate fee is attached.
- (e) Any laboratory owner applying for a new laboratory registration who has pending fees and/or penalties due from a previous laboratory registration when such laboratory was closed for non compliance with subsection (f) of this section must first remit to the SBDE the registration fee and penalties for each year such fees were not paid before the registration is approved and processed.
- (f) It shall be the duty of each laboratory owner to notify the SBDE in writing within 60 days of a change in: location of laboratory, closure of laboratory, the designated CDT or, in the case of a grandfathered lab, the designated employee. Changes of CDT's will require that proof of current CDT certification for the replacement CDT accompany said notification. Changes of designated employees for a grandfathered lab will require proof within six (6) months of the change that the designated employee meets continuing education requirements.
- (g) A person owning or operating a laboratory in the State of Texas must maintain the entire laboratory in a clean and sanitary condition without any accumulation of trash, debris, or filth, and such premises shall be maintained in full compliance with all health requirements of the city or county, or both, in which such a laboratory is located and in conformity with the health laws of the State of Texas.

(amended rule) Rule 116.4 Continuing Education

(a) Any laboratory renewing a certificate must provide proof that:

- (1) the designated CDT has met the continuing education requirements of the National Board For Certification For Dental Laboratory Technology or its successor, or:
- (2) in the case of grandfathered laboratories that the designated employee working on the premises of the dental laboratory has completed at least 12 hours of continuing education during the preceding 12 month period. Continuing education hours may only be used for one renewal period.
- (b) The continuing education shall be comprised of business management, infection control, and technical competency courses presented in seminars or clinics as accepted by a nationally recognized organization of dentistry or dental technology. The designated employee must complete at least one course in infection control annually. No more than one course in business management taken annually may be applied toward the continuing education requirement. Self study in a course approved by a nationally recognized organization of dentistry or dental technology may be taken for not more than four hours of the annual requirement.
- (c) In lieu of furnishing proof of continuing education as set forth in subsection (b) of this section, the dental laboratory may furnish proof that the designated dental technician has a current certification by the National Board For Certification For Dental Laboratory Technology or its successor. Certification as retired does not qualify the technician.

(amended rule) Rule 116.5 Exemption

- (a) The owner of a dental laboratory that was registered with the State Board of Dental Examiners September 1, 1987, is not required to submit proof that the laboratory has at least one certified dental technician employed by and working on the premises provided that:
- (1) the registration is continuous and remains current and all registration fees for the succeeding year are paid prior to the expiration of the registration:
- (2) the beneficial ownership of at least 51% interest in the laboratory is not transferred; and
- (3) the owner is employed on the premises of the laboratory at least 30 hours per week.
- (b) For this section, the designated employee of the dental laboratory must work on the premises a minimum of 30 hours per week.

(new rule) Rule 116.20 Definitions

The following words and terms, when used in this section, shall have the following meanings, unless the context clearly indicates otherwise.

Employee of a dental laboratory - a person performing dental services in a dental laboratory registered under Texas Civil Statutes Article 4551f.

Designated employee of a dental laboratory - the person so designated on the annual registration form of a grandfathered dental laboratory who meets continuing education and minimum employment requirements of these rules.

Designated CDT of a dental laboratory - the person so designated on the annual registration form of a CDT laboratory who meets the CDT certification requirement and minimum employment requirements of these rules.

Prescription - a written description of the kind and type of act, service, or material ordered by a licensed dentist, as defined in Article 4551 f (3)(a).

Laboratory Work Order - a written description of the kind and type of act, service, or material ordered by and between one or more Texas registered laboratories, pursuant to a prescription issued by a licensed dentist.

Grandfathered laboratory a laboratory that meets the provision of Rule 116.5 of this title (relating to Exemption).

(amended rule) Rule 116.22 In House Dental Laboratory

"In House Dental Laboratory" is a dental laboratory as described in 116.21 of this title (relating to Dental Laboratories) in which a dentist licensed to practice in Texas and his/her employees_performs, offers to perform or undertakes to perform any act or service listed in Texas Civil Statutes Article 4551f, Sec. 1 only for the patient(s) of that dentist or only for patient(s) of a professional corporation or partnership of which that dentist is an officer, partner, or employee. An in house dental laboratory must be located on the premises where the dentist or dental organization practices dentistry, and the laboratory does not employ more than two dental technicians.

(new rule) Rule 116.24 Registration Application

The Dental Laboratory Certification Council (DLCC) shall review each application for

registration or renewal of registration to determine if the applicant meets the requirements of Article 4551f. The DLCC shall provide the Board with a list of applicants who are eligible for registration with the Board. Applications will be forwarded with a recommendation to the State Board of Dental Examiners for registration if the provisions of Article 4551f and the rules in this section are met and the following criteria are met:

- (1) application/renewal is complete and all required information is provided,
- (2) current and active CDT certification for designated CDT, or, for grandfathered laboratories, proof of continuing education hours as outlined in Rule 116.4 of this title (relating to Continuing Education) is attached and current,

(3) appropriate fee is attached.

(new rule) Rule 116.25 Responsibility

Both the owner and manager and each of them named in an application to register a dental laboratory, irrespective of the person signing the application, are responsible for the proper registration and operation of the laboratory pursuant to the Dental Practice Act and these rules. The provisions of Article 4551(f) Sec. 7 and Sec. 8 providing that persons violating the Dental Practice Act are subject to criminal penalties and subject to loss of registration or refusal by the board to issue a registration, apply to the owner and manager of any dental laboratory having or seeking registration in Texas.

(amended rule) Rule 117.1 Exemptions

- (a) The definition of dentistry as contained in Texas Civil Statutes articles 4543- 4551j, as amended, shall not apply to the following:
- (1) Members of the faculty of a reputable dental college or school who are not licensed to practice dentistry in Texas where such faculty members perform their services for the sole benefit of such school or college.
- (2) Students of a reputable dental college or school who are candidates for a degree and who perform their operations without pay except for actual cost of materials, in the presence of and under the direct personal supervision of a demonstrator or teacher who is a member of the faculty of a reputable dental college or school approved by the State Board of Dental Examiners, or for and on behalf of and in a

school, hospital, state institution, public health clinic, or other facility approved for student dental service by the State Board of Dental Examiners.

- (3) Students of a reputable dental hygiene college or school who are candidates for a degree who practice dental hygiene without pay in strict conformity with the laws of this state regulating the practice of dental hygiene under the direct personal supervision of a demonstrator or teacher who is a member of the faculty of a reputable dental hygiene college or school approved by the State Board of Dental Examiners, or for and on behalf of and in a school, hospital, state institution, public health clinic, or other facility approved for student dental hygiene service by the State Board of Dental Examiners.
- (4) Dental interns who pursue advanced education in dentistry under the auspices of an institution, such as a dental school or hospital, which offers the type of advanced program designed to meet accreditation requirements as established by the Commission on Dental Accreditation of the American Dental Association. Dental interns may perform any clinical service included in the program of advanced education for which he/she is enrolled. as long as such service is accomplished under the auspices of the sponsoring institution, and as authorized by the program supervisor. A dental intern not licensed in Texas may not assess fees for clinical services rendered. An unlicensed dental intern may not engage in private practice.
- (5) Dental residents who pursue advanced education in dentistry under the auspices of an institution, such as a dental school or hospital, which offers the type of advanced program designed to meet accreditation requirements as established by the Commission on Dental Accreditation of the American Dental Association. The residency program usually follows an internship and the objective customarily is to prepare specialists in selected fields of clinical dentistry. Dental residents may perform any clinical service included in the program of advanced education for which he/she is enrolled, as long as such service is accomplished under the auspices of the sponsoring institution, and as authorized by the program supervisor. A dental resident not licensed in Texas may not assess fees for clinical services rendered. An unlicensed dental resident may not engage in private practice.
- (b) Members of the faculty of a reputable dental college or school who perform their services for the sole benefit of such school or college shall be entitled to apply for and to receive a non-renewable identification number issued by the

SBDE to be used solely for the purpose of applying for a Controlled Substances narcotics registration from the Texas Department of Public Safety and the Drug Enforcement Administration to prescribe, administer, or dispense controlled substances.

- (c) Dental interns and residents shall be entitled to apply for and to receive an identification number issued by the SBDE to be used solely for the purpose of applying for a Controlled Substances narcotics registration from the Texas Department of Public Safety and the Drug Enforcement Administration to prescribe, administer, or dispense controlled substances.
- (d) The SBDE will void each identification number issued to faculty members, two years after the date of issuance. Identification numbers issued to interns and residents will be voided upon the termination of the internship or residency as applicable.
- (e) The SBDE will notify the Texas Department of Public Safety and the Drug Enforcement Administration when an identification number is issued and when an identification number is voided.
- (f) Each application for an SBDE identification number shall be accompanied by a fee in an amount set by the Board.

(amended rule) Rule 119.3 Oral and Maxillofacial Pathology.

Oral and Maxillofacial Pathology is that branch of science which deals with the nature of the diseases affecting the oral and adjacent regions, through study of its causes, its processes and its effects, together with the associated alterations of oral structure and function. The practice of oral and maxillofacial pathology shall include the development and application of this knowledge through the use of clinical, microscopic, radiographic, biochemical or other laboratory examinations or procedures as may be required to establish a diagnosis and/or gain other information necessary to maintain the health of the patient, or to correct the result of structural or functional changes produced by alterations from the normal.

NOTICE OF EXPIRED LICENSES AND REGISTRATIONS

Listed on pages 14, 15, and 16 are licensees whose licenses or registrations are expired as of March 1, 1997. The SBDE notifies each licensee by mail of the impending expiration of a license or registration at least 60 days prior to the expiration date; however, each licensee is responsible to maintain current status by timely payment of annual fees.

The SBDE's intention is to ensure that all dentists, dental hygienists, and dental laboratories are eligible and within legal parameters to practice in Texas. Therefore, the SBDE publishes this list to notify other licensees, registrants, and the public that each of these individuals is not eligible to practice dentistry, dental hygiene, nor to operate a dental laboratory until his/her license or registration is renewed.

Because of the time lapse between the data retrieval of expired licenses and registrations and publication of this <u>Newsletter</u>, some names listed on the following pages already may have renewed - in which case they are practicing legally.

REMINDERS

CHANGE OF ADDRESS: You are responsible for notifying the SBDE office in writing within 60 days of the change of your address [Dental Practice Act, Article 4550 Sec 1]. License renewal notices are mailed to the address of record and if you have not updated your address, you may experience a late license renewal requiring that a late penalty be paid if your address is not current.

RENEWAL APPLICATIONS: Following are the most frequent mistakes made by dentists, dental hygienists, and dental laboratories on their application for renewal: (1) the entire renewal application is not filled out; (2) the renewal application is not signed; (3) a check or money order in the appropriate amount made out to the State Board of Dental Examiners is not included with the renewal application; (4) the renewal application arrives late (i.e., after the expiration date) at the SBDE, resulting in the addition of a late fee.

NOTE: Notice of renewals are mailed to licensees approximately 60 days prior to expiration of the license. If you do not receive your renewal, you may submit a written request to this office for a duplicate. COMPLIANCE IS THE RESPONSIBILITY OF THE LICENSEE.

ANESTHESIA PERMITS: The Dental Practice Act requires any dentist administering nitrous oxide/oxygen inhalation conscious sedation, parenteral conscious sedation, or general anesthesia to have a permit. Permit applications may be

obtained from the SBDE office. They are submitted to the SBDE, Director of Licensing and Examinations, and are reviewed and approved by the SBDE at regularly scheduled SBDE meetings.

<u>Please Note:</u> if you do not have written authorization from the State Board of Dental Examiners to administer conscious or general anesthesia, you may not be legally permitted.

<u>COPIES</u> of the <u>Texas Dental Practice Act</u> (statutory law as passed by the <u>Texas Legislature</u> regulating the practice of dentistry) may be obtained from the SBDE office by written request along with a fee of \$10.00.

COPIES of the SBDE Rules and Regulations (as promulgated by the Board to further clarify the Texas Dental Practice Act) may be obtained from the SBDE office by written request along with a fee of \$10.00.

CONSUMER INFORMATION SIGN:

A copy of the Consumer Information sign may be obtained from the SBDE office by written request along with a fee of \$3.00.

CONTINUING EDUCATION

Be aware that some organizations offering CE courses may be misleading Texas licensees taking these courses by stating that these course are eligible for CE credit in Texas. These courses may not qualify as "technical and scientific as related to clinical care" as outlined in Rule 104.1(5). The SBDE strongly recommends all licensees exercise good clinical judgment when seeking CE courses.

DO NOT submit CE documentation to the SBDE office unless you have been asked to do so. Random audits of Continuing Education records will begin in 1999 pursuant to Rule 104.5.
