- 7 a volunteer. The owner or manager of a water supply system that is
- 8 operated by a volunteer shall maintain a record of each volunteer
- 9 operator showing the name of the volunteer, contact information for
- 10 the volunteer, and the time period for which the volunteer is
- 11 responsible for operating the water supply system.
- 12 SECTION 2. Section 341.034(a), Health and Safety Code, is
- 13 amended to read as follows:
- 14 (a) A person who operates a public water supply on a
- 15 contract or volunteer basis must hold a registration issued by the
- 16 commission under Chapter 37, Water Code.
- 17 SECTION 3. The Texas Commission on Environmental Quality
- 18 shall adopt rules necessary to implement Sections 341.033 and
- 19 341.034, Health and Safety Code, as amended by this Act, not later
- 20 than December 1, 2015.
- 21 SECTION 4. This Act takes effect September 1, 2015.
