4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. The legislature, as authorized by Section
6	16.051(g), Water Code, designates the site of the proposed Ringgold
7	reservoir, to be located on the Little Wichita River in Clay County
8	approximately one-half mile upstream from its confluence with the
9	Red River, as having unique value for the construction of a dam and
10	reservoir and further determines that the reservoir is necessary to
11	meet water supply needs.
12	SECTION 2. This Act takes effect immediately if it receives
13	a vote of two-thirds of all the members elected to each house, as
14	provided by Section 39, Article III, Texas Constitution. If this
15	Act does not receive the vote necessary for immediate effect, this
16	Act takes effect September 1, 2015.


