Cox is retiring as the chief of police in Murphy on July 1, 2015, drawing to a close an outstanding career in 3 4 law enforcement that has spanned more than four decades; and 5 WHEREAS, After serving as a security officer in the United States Air Force from 1972 to 1978, Dr. Cox received a bachelor's 6 7 degree summa cum laude in law enforcement and police science from Sam Houston State University in 1979; he began his civilian career 8 9 in 1980 as a deputy sheriff in Montgomery County, and from 1981 to 10 1989, he was the chief of police and the city administrator of Oak Ridge North; during that time, he also earned a master's degree in 11 12 criminal justice management from the university; and 13 WHEREAS, Dr. Cox was the chief of police in Lamesa from 1989 14 to 1993, and then the chief of police in Corsicana from 1993 to 2008; he became Murphy's chief of police in 2008, and under his 15 16 leadership, the Murphy Police Department has attained recognized 17 status from the Texas Police Chiefs Association, and the community has scored among the top 10 safest cities in Texas, according to the 18 19 crime reporting system of the Federal Bureau of Investigation; and 20 WHEREAS, A graduate of the Federal Bureau of Investigation 21 National Academy, Dr. Cox has served as an adjunct instructor in 22 criminal justice at several institutions of higher learning in 23 Texas, and he is also a court qualified mediator; in 2011, he earned 24 a doctorate in public and urban administration from The University

- 1 of Texas at Arlington, and his dissertation, "Crisis in Police
- 2 Recruitment: Public Service Motivation and Changes in Generational
- 3 Preferences," has become a resource for police departments across
- 4 Texas; following his retirement from the Murphy Police Department,
- 5 he will become an assistant professor and director of the graduate
- 6 program in public administration at Tarleton State University; and
- 7 WHEREAS, Dr. Cox brings dedication, professionalism, and a
- 8 commitment to excellence to each of his endeavors, and he may indeed
- 9 reflect with pride on his many achievements throughout his more
- 10 than 40 years in law enforcement as he takes on new challenges and
- 11 opportunities in academia; now, therefore, be it

- 13 hereby congratulate Dr. G. M. Cox on his retirement as the Murphy
