4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 7.060, Education Code, is amended by
6	adding Subsection (a-1) to read as follows:
7	(a-1) The review conducted under Subsection (a) must
8	include a comparison of the reports and paperwork required by state
9	law and the reports and paperwork required by federal law. The
10	commissioner shall eliminate any reports or paperwork required by
11	state law that duplicate the content of reports or paperwork also
12	required by federal law.
13	SECTION 2. Section 11.201(d), Education Code, is amended to
