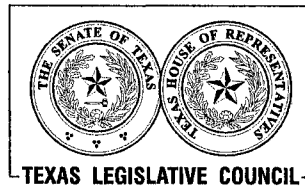

## Foreword

This publication catalogs interim studies to be conducted by state agencies and other state governmental entities, including interim committees, select committees, and advisory committees, pursuant to legislation or concurrent resolutions passed by the 84th Legislature that provide for a one-time or initial report to the legislature in 2016 or 2017. The publication does not include ongoing reports required by study provisions that do not expire.

The studies are organized by topic and, within each topic, in bill order. For each interim study in the publication, the following information is provided:

**Title**—Since the title of the study is not specified in the legislation, the titles used in this publication are developed based on bill or resolution language.

**Submitting Entity** (in parentheses)—The name of the state agency or other entity required to submit a report on the study.

**Legislation**—The bill and specific bill section(s) enacted by the 84th Legislature that contain provisions requiring the study, or the concurrent resolution passed by the 84th Legislature requesting the study.

**Description**—A summary description of the study. In most cases, the submitting entity is required to conduct the study, but, if applicable, other participating entities are noted. Report requirements also are briefly described if addressed in the legislation.

**Due Date(s)**—The deadline(s) for submitting the required report(s). If no due date is specified, this entry is omitted.

**Recipient(s)**—The persons or entities to whom the report must be submitted. If no recipients are specified, this entry is omitted.

**Expiration Date**—The date on which the bill or statutory provisions requiring the study expire. If no expiration date is specified, this entry is omitted.



## Appropriations and State Finance

---

### **Use of a Supplemental Appropriation Relating to Seismic Equipment, Seismic Networks, and Reservoir Behavior Modeling** (Bureau of Economic Geology, The University of Texas at Austin)

---

**Legislation:** House Bill 2, Section 16

**Description:** Report on the use of a supplemental appropriation to The University of Texas at Austin for the purchase and deployment of seismic equipment, maintenance of seismic networks, modeling of reservoir behavior for systems of wells in the vicinity of faults, and establishment of a technical advisory committee. Report must include certain data and modeling results, as well as costs necessary to maintain the TexNet Seismic Monitoring program after 2016.

**Due Date:** Not later than December 1, 2016

**Recipients:**

- Governor
- House Energy Resources Committee
- Senate Natural Resources and Economic Development Committee

## Business and Commerce

---

### **Alternative Electric Utility Ratemaking Mechanisms Adopted by Other States** (Public Utility Commission of Texas)

---

**Legislation:** Senate Bill 774, Section 1

**Description:** Study analyzing alternative electric utility ratemaking mechanisms adopted by other states. Report must include recommendations regarding appropriate reforms to the ratemaking process in Texas and an analysis that demonstrates how the recommended reforms would improve the efficiency and effectiveness of the oversight of electric utilities and ensure that electric rates are just and reasonable.

**Due Date:** Not later than January 15, 2017. Postpones the completion of a study on any periodic adjustment of the rates of electric utilities that is approved by the Public Utility Commission of Texas, making the study available for review by January 31, 2019, rather than by January 31, 2017.

**Recipient:** Legislature

**Expiration Date:** September 1, 2019

## Courts

---

### Establishing a Statewide Uniform Attorney Ad Litem Billing System (Office of Court Administration)

---

**Legislation:** Senate Bill 1369, Section 2

**Description:** Study of the feasibility of establishing a statewide uniform attorney ad litem billing system.

**Due Date:** Not later than December 31, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house

**Expiration Date:** September 1, 2017

## Criminal Justice

---

### Progress in Meeting Incident-Based Crime Statistics Reporting Goal (Department of Public Safety)

---

**Legislation:** House Bill 11, Section 10

**Description:** Report relating to progress made on the Department of Public Safety (DPS) goal that, not later than September 1, 2019, all local law enforcement agencies will have implemented an incident-based reporting system for submitting to DPS information and statistics concerning criminal offenses committed in the jurisdiction of the local law

enforcement agency. Report must identify the number of local law enforcement agencies that have implemented the system.

**Due Date:** Not later than January 1, 2017

**Recipient:** Legislature

## **Exoneration Cases Since 2010 (Timothy Cole Exoneration Review Commission)**

---

**Legislation:** House Bill 48, Section 1

**Description:** Review of cases in Texas in which an innocent defendant was convicted and then, on or after January 1, 2010, was exonerated. Report must include findings on the causes of wrongful convictions and recommendations on ways to prevent future wrongful convictions.

**Due Date:** Not later than December 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house
- Legislature
- Texas Judicial Council

**Expiration Date:** December 1, 2016

---

## **Implementing a Pay-for-Performance Contract Program for Certain Criminal Justice Programs and Services (Texas Department of Criminal Justice)**

---

**Legislation:** House Bill 307, Section 1

**Description:** Study on the feasibility and potential costs and benefits of implementing a pay-for-performance contract program under which the Texas Department of Criminal Justice (TDCJ) would contract for the operation of criminal justice programs or the provision of criminal justice services. Report must include the results of the study and TDCJ's recommendations for implementing such a program.

**Due Date:** Not later than November 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Presiding officers of the standing committees of the senate and the house with primary jurisdiction over criminal justice programs and services

**Expiration Date:** January 1, 2017

---

**Care of Pregnant Prisoners Confined in County Jails  
(Commission on Jail Standards)**

---

**Legislation:** House Bill 1140, Section 2

**Description:** Report relating to compliance with the requirement that each sheriff report to the Commission on Jail Standards regarding the implementation of policies and procedures to provide adequate care to pregnant prisoners confined in a county jail.

**Due Date:** Not later than December 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house
- Standing committees of the senate and the house with primary jurisdiction over matters relating to corrections

**Expiration Date:** February 1, 2017

---

**Penal Laws Other Than Criminal Offenses Under Certain Statutes  
(Commission to Study and Review Certain Penal Laws)**

---

**Legislation:** House Bill 1396, Section 29

**Description:** Study of all penal laws in Texas, other than criminal offenses, under the Penal Code, under the Texas Controlled Substances Act, or related to the operation of a motor vehicle. Report must include any specific statutes the commission recommends revising or repealing.

**Due Date:** Not later than November 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house

- Supreme Court of Texas
- Texas Court of Criminal Appeals
- Standing committees of the senate and the house with primary jurisdiction over criminal justice

**Expiration Date:** December 31, 2016

## **Economic Development**

---

### **Promoting the Aerospace and Aviation Industries**

(Aerospace and Aviation Office of the Texas Economic Development and Tourism Office)

---

**Legislation:** Senate Bill 458, Section 1

**Description:** Report on short-term and long-term statutory, administrative, and budget-related policy initiatives and reforms the state may undertake or implement to promote the aerospace and aviation industries.

**Due Date:** Not later than December 1, 2016. Subsequent reports to the legislature are required under provisions that do not expire.

**Recipients:**

- Governor
- Legislature

**Expiration Date:** September 1, 2017

---

### **Development of a Cruise Industry on the Texas Coast between Calhoun and Cameron Counties**

(Joint Interim Committee Created by the Lieutenant Governor and the Speaker of the House)

---

**Legislation:** House Concurrent Resolution 108

**Description:** Study regarding development of a cruise industry on the Texas coast between Calhoun and Cameron Counties, including its potential economic impact and options for incentives to attract the cruise industry to South Texas.

## Environment

---

### **Current and Potential Economic Impacts of Recycling (Texas Commission on Environmental Quality)**

---

**Legislation:** House Bill 2763, Section 2

**Description:** Study of the current and potential economic impacts of recycling, including state and local revenue that may be lost because recyclable materials are not recycled. Results of the study must be included in a 2016 summary report on municipal solid waste.

**Expiration Date:** August 31, 2017

---

### **Creating and Maintaining a Coastal Barrier System (Joint Interim Committee to Study a Coastal Barrier System)**

---

**Legislation:** Senate Bill 695, Section 1

**Description:** Continuation of a study on the feasibility and desirability of creating and maintaining a coastal barrier system in Texas that includes a series of gates and barriers to prevent storm surge damage to gulf beaches or coastal ports, industry, or property. Report must contain findings and any recommendations developed by the committee.

**Due Date:** Not later than December 1, 2016

**Recipients:**

- Governor

## Family Law

---

### **Activities in the Dallas Community Addressing Family Violence (Health and Human Services Commission)**

---

**Legislation:** House Bill 77, Sections 2, 3, and 5

**Description:** Study conducted by the Health and Human Services Commission (HHSC), in conjunction with a statewide coalition on family violence, of activities in the Dallas community addressing family violence, with a specific focus on the Dallas Men Against Abuse program, to determine if any or all of those activities or program aspects should



be implemented in other areas of Texas. Report must include the results of the study and HHSC's recommendations.

**Due Date:** Not later than December 1, 2016

**Recipient:** Legislature

---

## **Homeless Youth** (Texas Department of Housing and Community Affairs)

---

**Legislation:** House Bill 679, Section 1

**Description:** Study on homeless youth by the Texas Department of Housing and Community Affairs, in conjunction with other members of the Texas Interagency Council for the Homeless, to include information on the number of homeless youth in Texas, the needs of homeless youth and the degree to which current programs meet those needs, sources of funding for homeless youth services, and a strategic plan for reducing youth homelessness in Texas. Report must include a summary of the study results and recommendations for changes in law necessary to assist homeless youth.

**Due Date:** Not later than December 1, 2016

**Recipient:** Legislature

**Expiration Date:** September 1, 2017

---

## **Best Practices for the Uniform Collection and Reporting of Information Relating to Family Violence and Certain Other Offenses** (Task Force to Promote Uniformity in Collection and Reporting of Information on Family Violence, Sexual Assault, Stalking, and Human Trafficking)

---

**Legislation:** House Bill 2455, Section 1

**Description:** Examination of best practices for the uniform collection and reporting of information relating to family violence, sexual assault, stalking, and human trafficking as well as for the implementation of dating violence training and awareness education in public schools. Report must include policy recommendations and best practices guidelines developed by the task force.

**Due Date:** Not later than September 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house
- Appropriate standing committees of the senate and the house

**Expiration Date:** September 1, 2017

## **Health and Human Services**

---

### **Benefits of Prenatal Surgical Procedures to Treat Birth Defects (Health and Human Services Commission)**

---

**Legislation:** House Bill 606, Section 1

**Description:** Study on the costs and benefits of prenatal surgical procedures to treat birth defects to include an evaluation of any type of prenatal surgical procedure that is or becomes the standard of practice for treating a birth defect. Report must include the results of the study.

**Due Date:** Not later than December 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house
- House Committee on Public Health
- Senate Committee on Health and Human Services

**Expiration Date:** September 1, 2017

---

### **Laws, Standards, and Policies Regarding Parking for Persons with Disabilities (Governor's Committee on People with Disabilities)**

---

**Legislation:** House Bill 1317, Section 1

**Description:** Report on laws in Texas and other states that apply to parking for persons with disabilities, federal requirements for parking for persons with disabilities, and policies on parking for persons with disabilities in state-owned parking lots.

**Due Date:** Not later than November 1, 2016

**Recipients:**

- Governor
- Lieutenant governor
- Speaker of the house
- Standing committees of the senate and the house with primary jurisdiction over transportation

**Expiration Date:** January 1, 2017

---

**State-Funded Parenting Education Programs**  
(Department of Family and Protective Services)

---

**Legislation:** House Bill 2630, Section 7

**Description:** Report on certain state-funded parenting education programs provided by the Department of Family and Protective Services. Report must include the status of the programs, a description of the programs along with the models associated with them, and information on the number of families served by the programs.

**Due Date:** Not later than December 1, 2016. Subsequent reports to the legislature are required under provisions that do not expire.

**Recipients:** Standing committees of the senate and the house with primary jurisdiction over child protective services

**Expiration Date:** January 1, 2017

---

**Effectiveness of the Relative and Other Designated Caregiver Placement Program**  
(Department of Family and Protective Services)

---

**Legislation:** House Bill 2655, Section 1

**Description:** Study of the effectiveness of the relative and other designated caregiver placement program. Report must include recommendations for improving the program.

**Due Date:** Not later than January 1, 2017

**Recipient:** Legislature

**Expiration Date:** September 1, 2017

---

**Pilot Program to Provide Protective Services to Persons at Risk of Future Harm**  
(Department of Family and Protective Services)

---

**Legislation:** House Bill 3092, Sections 1 and 3

**Description:** Report on a pilot program to evaluate the feasibility and associated benefits of providing protective services when an elderly person or person with a disability has been determined to be at risk of future harm from abuse, neglect, or exploitation but is not in a state of abuse, neglect, or exploitation. The first report must provide preliminary findings, and the second report must include recommendations for the continuation, elimination, or expansion of the pilot program.

**Due Date:** Not later than December 15, 2016. The second report is due not later than December 15, 2017.

- Standing committees of the senate and the house with primary jurisdiction over health and human services

**Expiration Date:** September 1, 2019

---

**Developing a Central Database of Information About Incapacitated Persons Under Guardianship**  
(Office of Court Administration)

---

**Legislation:** House Bill 3424, Section 1

**Description:** Study of the feasibility of developing, implementing, and maintaining a computerized central database that contains the names of incapacitated persons and each person's guardian's name and contact information. Study must include a review of best practices for protecting the privacy of the individuals and the confidentiality of information included in the database. Report must contain the results of the study.

**Due Date:** Not later than December 1, 2016

**Recipients:**

- Lieutenant governor
- Speaker of the house
- Appropriate standing committees of the senate and the house

**Expiration Date:** September 1, 2017

---

**Costs and Outcomes Under the PACE Program  
(Health and Human Services Commission)**

---

**Legislation:** House Bill 3823, Section 1

**Description:** Evaluation of the PACE program (program of all-inclusive care for the elderly) conducted by the Health and Human Services Commission (HHSC), in collaboration with the Department of Aging and Disability Services and appropriate stakeholder groups, that compares Medicaid costs and client outcomes under the PACE program to Medicaid costs and client outcomes under the STAR + PLUS Medicaid managed care program. Evaluation must include an assessment of future cost implications if HHSC failed to establish a reimbursement methodology under the PACE program in accordance with the bill's provisions. Bill requires a report on the findings of the evaluation.

**Due Date:** Not later than December 1, 2016

**Transferring Operation of the Austin State Hospital to a New Facility at a  
New Location  
(Health and Human Services Commission)**

---

**Legislation:** Senate Bill 200, Section 2.26

**Description:** Study conducted by the Health and Human Services Commission, in coordination with the Department of State Health Services, the General Land Office, and the Texas Facilities Commission, to determine the feasibility, costs, and benefits of transferring operation of the Austin State Hospital from the hospital's facilities as of January 1, 2015, to a new facility at a new location. Report must contain the results of the study.

**Due Date:** Not later than September 1, 2016

**Recipients:**

- Standing committees of the senate and the house with primary jurisdiction over health and human services
- Sunset Advisory Commission
- Legislative Budget Board

**Expiration Date:** September 1, 2017

---

**Expansion of Authorization Agreements Regarding a Child**  
(Department of Family and Protective Services)

---

**Legislation:** Senate Bill 206, Section 88

**Description:** Study to determine whether authorization agreements under Chapter 34, Family Code, relating to certain authorizations given by a child's parent to a child's relative, should be expanded to include authorization agreements between a child's parent and a person who is unrelated to the child. Report must include the Department of Family and Protective Services' study recommendations.

**Due Date:** Not later than December 31, 2016

- Legislature

**Expiration Date:** September 1, 2017

---

**Improving the Survey, Inspection, and Informal Dispute Resolution Processes for Long-Term Care Facilities**  
(Long-Term Care Facility Survey and Informal Dispute Resolution Council)

---

**Legislation:** Senate Bill 914, Sections 6 and 7

**Description:** Study and recommendations regarding best practices and protocols to make survey, inspection, and informal dispute resolution processes more efficient and less burdensome on long-term care facilities. Report must recommend uniform standards for those processes.

**Due Date:** Not later than January 1, 2017

**Recipients:**

- Speaker of the house
- Chairs of the appropriate standing committees of the senate and the house
- Executive commissioner of the Health and Human Services Commission

**Expiration Date:** June 1, 2017

**Establishing a Prescription Drug Donation Pilot Program**  
(Department of State Health Services)

---
