### Shining a Light on State Spending

Texans deserve to know how their government spends their money. The Comptroller's *Where the Money Goes* Web site at www.window.state.tx.us/ wherethemoneygoes offers a virtual check register available to anyone at any time to drill down to specific details on state expenses.

The Comptroller's *Open Book Texas* initiative www.openbooktexas.com has taken this effort a step further by linking to information on leveraging the state's buying power through TxSmartBuy, showcasing financial transparency on the local level with the Texas Transparency Check-up, and studying how the state's information systems can better share data through a "single set of books."

## Saving Through Simpler, Smarter, Faster Solutions

The state is growing, and the need for state services is growing with it. To meet increased demand with existing resources, the Comptroller's office is dedicated to streamlining and improving business processes to save taxpayer dollars. This effort already has led to more than \$8.5 million in year over year cost savings/cost avoidance for the agency.

On a statewide level, the Comptroller's office closely studied the vast array of goods and services purchased by the state to identify smarter ways to buy and save. The first phase of this effort focused on several of the state's largest spending categories with initial estimated savings of \$28 million.

## Providing Educational Opportunities for All Texans

To help offset increasing college tuition costs, the Comptroller's office unveiled the *Texas College Savings Plan*, the *Lonestar 529 Plan*, and the *Texas Tuition Promise* expenses and prepay tuition at today's rates.


## Making it Fast and Easy to Find the Information You Need

The Comptroller's office launched a complete redesign of its Window on State Government Web site for a more transparent, streamlined and user-friendly experience that helps users quickly locate the information they need. The office also launched the Texas Ahead economic development portal, the Every Chance, Every Texan work force and education portal, the Transparency Check-Up and Open Book Texas sites, and a refreshed State Energy Conservation Office Web site with new navigation, organization and search capabilities.





# Texas and the Future — Challenges Ahead

### State Budget

Budgeting for the 2010-11 biennium will present challenges to state lawmakers. The Comptroller's Biennial Revenue Estimate includes an estimated \$77.1 billion available for general purpose spending during the period, approximately \$9.1 billion less than the 2008-09 biennium.

#### Water

The Comptroller's 2009 report, *Liquid Assets: The State of Texas' Water Resources*, examines Texas' current and future water resources, the practical and policy barriers facing local and statewide water planners and possible funding mechanisms that could be tapped to develop Texas' water resources. More than 46 million people could call Texas home by 2060, and failing to meet their water demands could cost Texans and businesses \$98.4 billion.

### Energy

Texas remains at the forefront of the nation's energy industry. The direction Texas takes in energy policy will help mark the path for the nation. Texas — and the rest of the world, for that matter — almost certainly will meet future energy demands using a wide variety of resources, and our state must be informed to ensure it remains well positioned to benefit from the increasing diversification of the nation's energy portfolio. This issue is covered in-depth in the Comptroller's 2008 *Energy Report*.

### Texas Work Force

The Comptroller's December 2008 report, *Texas Works*, examines the changing Texas job market and the growing shortage of workers with the technical skills required for many of the state's fastest growing jobs. The report details the offerings of community and technical colleges to fill those educational needs, but also explores the fact that too many Texas high school students fail to pursue postsecondary education.

### Economic Outlook

The following table provides key measures of the state's economic outlook. Gross State Product is a measure of the total value of goods and services produced in Texas. Nonfarm Employment represents the number of jobs in the economy, not including jobs relating to the farming industry.
